Granger selected from more than 200 applicants for OGE scholarship

D uring a special ceremony Tuesday, OGE Energy Corp. Foundation announced a Piedmont High school graduating senior was named the company's 2023 Positive Energy Scholar.

Blaine Granger will receive \$60,000 in scholarship funds over four years to cover tuition, books, fees and on-campus room and board.

Oklahoma Gas & Electric (OG&E)

representatives, Piedmont Public Schools Interim Superintendent Lisa Campbell, teachers, students and other members of the community gathered at Piedmont High School to surprise Granger after an award ceremony to celebrate his academic accomplishments.

The Positive Energy Scholarship will provide Granger the opportunity to attend the University of Oklahoma in the fall and major in music education without the financial burden often associated with pursuing a higher education.

"Congratulations to Blaine, one of our 2023 Positive Energy Scholars and the second winner from Piedmont High School," said Sean Trauschke, OGE Energy Corp. chairman, president and CEO. "Blaine's passion for learning and volunteering shows his dedication to academics and uplifting others in the community. It is an

Piedmont Library and Cultural Events Society meets needs of local libraries

"Oh", the Places You'll Go" is one of the more popular titles seen in reference to libraries, and it coincides with the mission of the Piedmont Library and Cultural Events Society (PLACES) because their mission is to help the library with its needs, speak to the townspeople to learn what they want from the library, and organize community events, such as the Founder's Day Art Show.

This spring, PLACES awarded two local librarians with a box of around 17 books, including diverse titles and multiple Newberry and Caldecott award winners.

The two awarded librarians, Candice Boesch from Stone Ridge Elementary and Mem McCutchan of the Early Childhood Center, along with others applied for the PLACES scholarship, which offered the opportunity to buy new hardback books that their budgets might not allow for. The hardback books are more durable and would be able to serve more children over the years.

"The books received as part of the PLACES grant will encourage more student reading by putting interesting, beautiful books in their hands. Seeing a book with one or more medals on its cover doesn't hurt," said Boesch. "The books are also available to our teachers to share with their classes, offering even more exposure and further piquing students' interest."

Boesch said she chose multiple Caldecott Award winners and other awarded books, because she does

"I wasn't going to relocate just anywhere. It had to be a school district that stood for excellence. Piedmont Public Schools


> is the perfect place for me," said Spears.

Caldecott lessons with students to explain the award and its significance. She continued to so her lessons include several Caldecott books so showcase the beautiful illustrations.

The Piedmont Public Library and PLACES representatives presented the books during one of her classes which caused her students to erupt with cheering and applause. Boesch said the students could not wait to check out the new books and the class immediately read a few.

Michelle Ferguson, Piedmont's head librarian, said PLACES plans to offer two opportunities, one for the fall and one for the spring, for librarians to apply for the scholarship. Over the last two and a half years, PLACES had funded grants for local school librarians, with the money coming from private donations and a Microsoft partnership for volunteer efforts and community enrichment. In 2021, PLACES gave \$1,000 in brand new hardback books to seven different schools.

PLACES has already impacted many students' lives with their grants to local schools, and will continue to place new hardback books into the hands of students who need them. A few of the books Boesch received, include "Have You Ever Seen a Flower?" by Shawn Harris, "The Rough Patch" by Brian Lies, "Hello Lighthouse" by Sophie Blackall, and "Me & Mama" by Cozbi A. Cabera.

BeReal or BeFake? Can new app make us all more authentic?

BeReal, one of the newest social media platforms, hit the market in 2020. The French social media app was designed by Alexis Barrreyat and Kevin Perreau and gained popularity in the last year. The app's daily notification encourages users to share a photo of themselves and their surroundings within a randomly selected two-minute window, with the goal of posting within the window.

A growing thought surrounding social media is that it encourages users to be unauthentic and to post just a highlight reel of their lives. Every Instagram or Facebook post you like is most likely a three-minute cross section of someone else's life - but it looks glorious and certainly greener on their side of life.

Maybe it's someone's vacation, wedding or promotion, which deserves a pat on the back and a "congratulations" comment, but we don't see the reality behind those photos, such as the crying child or horrendous sunburn.





Piedmont schools puts out call for help with bus routes

Piedmont Public Schools has a critical need for bus drivers, and Director of Transportation Josh Critchfield has found a new and different way of welcoming new members to the family.

That way is a May 20 event, "Donuts and Drivers," held from 9:30 a.m. to noon at the district bus barn at 802 NW 2nd Street in Piedmont.

"The idea is to give anyone interested the chance to come and experience the culture, have a cup of coffee with us," Critchfield said. "We want people to see that it's not a big scary school bus, it's really a great opportunity to do something great for the kids and our department is really a wonderful environment."

The district needs seven new bus drivers for the start of the 2023-24 school year, which starts in August. When searching for new drivers, it can sometimes be a challenge to recruit them in the same way many other staff members and teachers apply – via the district website.

"The people we're looking for – sometimes they are retired or semi-retired and they aren't as familiar with or care that much about technology, so it's not easy or convenient for them to apply online," Critchfield said. "We're also hoping that coming and meeting with us in person, asking questions and being able to talk about what it takes to become a bus driver will relieve any hesitation someone might have – and it also gives them a chance to see and get on a school bus."

Drivers are hired on a six-hour contract, which gives them eligibility for the same benefits teachers get – including retirement and healthcare. Hours may vary slightly but are generally 6-9 a.m. and 2-5 p.m. on days school is in session, Critchfield said.

Base pay for someone with no experience is 17 per hour, with increases based on experience. All district employees are paid once a month – for bus drivers the contract is for 173 days annually.

"Whatever they make annually gets broken into 12 equal payment," Critchfield said.

Most people who can drive a car can be a bus driver, the transportation director said.

"We provide all start to finish training inhouse and will work with everyone step-bystep," he said. "You don't need to have experience – we've had people who haven't driven a car

for 30 years who are excellent bus drivers."

District personnel go to the state driving test with new hires and help walk them through the licensing process.

The need for drivers is especially significant this year because several bus drivers have retired or left the district; several teachers and coaches serve as bus drivers and some have left the district or have been reassigned, Critchfield said. There has also been significant growth in the PPS district, with large subdivisions cropping up, particularly near County Line Road, he said.

"We hope we get to meet a lot of people, get to know them and let them see what a great district and a great department we have," Critchfield said.

"I knew that I had a decent finish, but I knew the guys behind me could also finish really well," Humes said. "So, I told myself I had to go early if I wanted a chance of out-kicking them."

When Humes decided to accelerate on his final lap, no one could keep pace with the Wildcat junior.

By the time his push ended, Humes had opened up a wide enough lead to take a peek back at his nearest competition as he closed in on the finish line. As Humes crossed, he let out a roar of satisfaction in celebration of his third gold medal in two days at the Class 5A state track meet at

12 years, and these kids...I knew it was their year," said head coach Brad Brucker, who has been with PHS for all but one season since the program's inception in 2011. "It feels so amazing to know that all that hard work has paid off."

Brucker's message to his team during the lead-up to Friday night's game was that unity and resilience would be the key to beating a McGuinness squad that had won seven straight against PHS, including a 1-0 victory in last season's state title game.

As the game neared the 100-minute mark on a night when heat indices neared 95 degrees, Hahn embodied Piedmont's collective will-power to break its slump vs. the Irish with one final and decisive push.

"We've wanted this for so long. We deserved this win and I'm so proud of us," Hahn said.

Hahn put PHS in front in the 27th minute with a smooth finish off a well-placed set piece from Evelyn Sydnes. Bishop McGuinness surrendered only four goals this season and Hahn accounted for three of them.

"She showed her mettle tonight," Brucker said. "We could not be more proud of her and this whole group."

Though Hahn netted the gamewinner for the Lady Wildcats, PHS sophomore goalkeeper Hattie Morris saved the day more than once. Under constant attack from a relentless McGuinness offense throughout both halves and in overtime, Morris never flinched.

She made a diving save to prevent a goal in the first half and leaped high to deflect away another scoring opportunity for the Irish in the second. Even when Reese Roberts chipped home the equalizer for McGuinness in the 60th minute, Morris kept her

"That was just a good shot. Kudos to them, but I knew I had to play my hardest," she said while fighting back tears. "I just really wanted to win."

When McGuinness had to have a goal in overtime, Morris proved to be unbeatable.

"Hattie had the game of her life and we don't win that game without her," Brucker said. "She was absolutely amazing. The diving save she made in the first half was the absolute best save I've seen in the women's game in 12 years."

Morris didn't play in last season's state championship game, but she took in the atmosphere on the sideline at Taft Stadium. That

helped her to smooth out any pregame nerves on Friday night, she said.

"I got to experience it last year, so I had a feel for it and I felt like I was prepared," Morris said. "I was just ready to get after it."

She credited teammates Jacqueline Stovall, Fallyn Brock, Ali Daugherty, Brekyn Cope, Rylie Burnett, Braxtyn Turner, Brianna Butler and others for giving her the confidence to play her best game at the most important time.

"They were able to provide structure for me and they were able to get the ball out when I needed them to get it out," she said.

Morris was on the opposite end of the field for Hahn's game-winner but was able to see her break free.

"I was thinking go Jordan, go Jordan, go Jordan," Morris said.

Droves of Piedmont fans made the trek to Newcastle Friday evening. The visiting side stands overflowed with blue and yellowclad supporters. Hundreds more PHS backers lined a chain link fence that ran from one end of the field to the other.

'I'd love to tell every one of them thank you personally," coach Brucker said. "Tonight doesn't happen without their support."

A few days after Piedmont's seasonending loss to Bishop McGuinness, first-year head soccer coach Thomas Sedgwick still hadn't moved past the 1-0 setback.

"We were dominating the game. We were putting pressure on them and had three or four chances to go ahead," he said. "But we couldn't stick the ball in the back of the net."

Keeper Jay Brinsfield added a clutch save on a penalty kick attempt from the Irish in the first half. McGuinness also had a goal disallowed because of a handball call.

"We told the boys at half that luck was on our side and that we had to turn it into a physical goal," Sedgwick said.

It wasn't meant to be, though. Late in the second half, McGuinness got loose on the wing and fired a shot that beat Brinsfield to the far corner.

Grove upsets Piedmont in state quarterfinals

JENKS — Piedmont's baseball team had big plans for its fourth consecutive trip to the state tournament, but they were cut short last Thursday.

Grove starting pitcher James Wise pitched a complete game shutout as the Ridgerunners upset the Wildcats, 2-0, in a Class 5A quarterfinal played at Jenks High School's Hinch Field.

Caden Gain provided the game-winning one-out, two-RBI-double in the fifth inning for Grove, which won for the 13th time in 14 tries.

It was an abrupt and surprising end to an otherwise storybook season for PHS, which finished as district and regional champions with a record of 28-10.

"I really liked our odds going into it. I didn't have anything prepared to say to the guys because I didn't expect to lose in the first round," Piedmont head coach Adam Skokowski said. "But, it's the state tournament. No matter what state tournament it is, in any class, when you get here any team can beat you at any time. I'm proud of these guys and what they've done."


Wise pitched seven innings with seven strikeouts and three walks while scattering four hits as the senior southpaw handed Piedmont its first quarterfinal-round loss since a 4-2 defeat to Pryor in 2019. Wise's fastball topped out in the high 80s and he also mixed in a slider, but Skokowski estimated that 80% of Wise's pitches were fastballs.

"He tried to make us prove we could hit his fastball and we didn't. He had a helluva outing," Skokowski said.

"He's got some arm-side run. The ball moved a lot and he pounded the inside corner. He throws from a low arm slot and from the angle it looks like it's coming at you, and it peels back over the plate."

Piedmont starter Jakeb Koop went toe-totoe with Wise for six innings. The senior righty struck out nine batters and allowed only three hits and two earned runs while lowering his career ERA at the state tournament to 1.98.

"Koop threw lights out and that's twice for him in the state tournament, because he closed up shop on Sapulpa in the semifinals last sea-

son," Skokowksi said. "They got a big hit with runners on base. He was nails other than that."


The Wildcats had multiple chances to take the lead. In its first at-bag, PHS stranded a runner on second base and in the third inning, back-to-back singles from Luke Hill and Nicholas Elmhorst went to waste.

Down to their final three outs, the Wildcats loaded the bases with a pair of walks and a hitby-pitch, but Wise got a called strike three to seal the upset.

"We get one big hit right there and it's a gamechanger," Skokowski said. "It came down to clutch hitting and it just wasn't our day."

Weston Thomas and Jackson Harriger each singled and finished 1 for 4 on the day. Thomas also pitched one scoreless inning in relief of Koop.

Looking ahead, Piedmont will lose some key pieces from this team. Starting pitchers Jackson Califano and Koop, as well as catcher Jackson Harriger, graduate. Leading hitter Noah Smith and starting infielders Cole Girard and Logan Hill must also must be replaced.

Twisters' likely in El Reno, but not yet

Filming planned in Jenks Simmons Field House; crews in Okarche last week

he storm will have to wait, at least for a bit. Plans to start filming Twisters in El Reno – and in particular Jenks Simmons Field House - were pushed back a bit until dates can be found that don't conflict with other already scheduled activities.

El Reno City Councilwoman Amy Neathery requested a permit that would allow Universal Studios to begin production here be tabled until a May 23 special council meeting. She said El Reno Public Schools had a conflict with the timing of the planned film production. Council agreed to delay the request until the upcoming special meeting.

El Reno School Superintendent Matt Goucher said on Wednesday, the district had received a request for two dates the production company wanted to film at the Jenks Simmons Annex. He said after reviewing the request, it was realized the Annex had already been booked for those dates.

"It stays pretty full the entire summer," Goucher

said, referring to Jenks Simmons. He said basketball, wrestling camps and other activities use the field house during summer months.

Goucher said there is "no problem" with the production company using Jenks Simmons, it just needs to happen when other activities have not already been scheduled there.

Neathery said she was certain dates could be found to accommodate the filmmakers.

And from the sounds of it, Twister 2 is going to be a major film production.

Steve Maddox of the El Reno Film Commission told the council the production will be one of the "top movies of 2024." He said the Centre Theatre as well as the downtown area are "why the movie is being made here and not in Georgia."

Maddox said a crew of more than 500 people will be coming and going during the production, expected to last in El Reno for some three weeks.

Maddox said El Reno will reap "major" attention from the movie. He said producers plan to keep the name El Reno in the movie and will build another

trolley car. "They want to tip it over."

Maddox said he is hopeful Universal will agree to leave the "movie trolley" here so it can become a tourism attraction.

Maddox said downtown El Reno will be featured in the final scene of the movie, or what he described as "the hero scene." He said the scene will "blow your mind."

Mayor Steve Jensen said the timing of Twister 2 comes at an opportune time. Jensen said with the film scheduled to be released in 2024, it will give El Reno great exposure ahead of the 2026 centennial celebration of Route 66.

Jensen said at a recent gathering of Route 66 communities in Arcadia, Lt. Gov. Matt Pinnell said the state plans to spend "\$30 million" over the next five years to help make improvements along the historic highway.

"That's going to be \$6 million a year for the next five years," Jensen said.

He said the state wants to invest in attractions that can help attract visitors during the centennial year and beyond.

to maintain its lane while crossing the Caddo Jake Bridge, Anderson stated in his affidavit.

The deputy learned Danker had previously been charged with driving under suspension in April 2005 in Lincoln County and in January 2017 in Oklahoma County. He also found her insurance policy was expired.

The vehicle was impounded.

Anderson transported Danker to the Canadian County Jail, where she told Capt. Austin Moore and the deputy that she did not have any contraband and was not using any illegal drugs.

"When we arrived at the jail, Tessie was changed out of her street clothes and into the Canadian County Jail inmate uniform by a female detention officer," according to deputy Anderson's affidavit.

"Detention staff then conducted a full body scan of Tessie using the body scan machine. Detention staff advised that on the scan monitor, it was shown that Tessie had what they believed to be contraband located inside her person/pelvic area."

Danker then retrieved the contraband from her pelvic area and it was placed in an evidence bag.

HALF A GRAM AND A PIPE

Deputy Anderson asked Danker why she did not tell him about the contraband, and she reportedly replied that she was scared.

She admitted having half of a gram of meth and the pipe, according to the court affidavit.

Bringing contraband into a jail is a felony punishable by one to five years in state prison and/ or a \$100-\$1,000 fine. Driving with a suspended license is a misdemeanor punishable by up to one year in jail and/or a \$200-\$750 fine.

Danker was released from custody Feb. 20 on bonds totaling \$3,500, district court records show.

The defendant's previous felony convictions in Oklahoma and Lincoln counties for distribution of controlled dangerous substances and possession of controlled substances led to her serving in state prison between 2015 and 2019, state Department of Corrections records show.

Two drug trafficking cases against Danker are pending in Oklahoma County.

Canadian County detention officers since late October 2022 have been using a Tek 84 full-body scanner to catch inmates trying to conceal drugs, weapons and other contraband before they enter the county lock-up.

Canadian County commissioners approved the \$147,000 purchase in April 2022.

That action was prompted after several inmates attacked fellow prisoners using hand-fashioned weapons, one inmate set fire inside a cell and another snuck a cell phone inside the jail.

Detention Capt. Moore called the body scanner a "great tool – a great deterrent.

"Every jail is going to have that issue of contraband," he said. "Any tool we can come up with to try to limit that as much as possible is always going to benefit the safety and security of the jail staff and the public."

El Reno city hall to implement summer hours, could become permanent

The El Reno City Council moved forward on a number of projects at last week's regular monthly meeting and agreed to alter the office hours at City Hall over the summer.

The new summer hours will be Monday through Thursday from 7:30 a.m. to 5:30 p.m. On Friday, offices will open at 7:30 and will close at 11:30 a.m. City Manager Matt Sandidge said the new hours will take effect May 30 and will run to Labor Day. He said a number of municipal governments have gone to this format and are finding success with it, including Mustang. The new times are considered a "trial," but if the system works, it could be adopted after Labor Day, Sandidge said. Hours have normally been 8:30 to noon, with offices closed for lunch until 1 p.m., with closing time set at 5 p.m. The new format will actually extend office hours as City Hall opens earlier, remains open over lunch and does not close until 5:30. Council also agreed to wrap up the COVID Response Project, approving a resolution supporting how the federal funds were administered.

Millie Vance, who for years has worked with the city on Community Development Block Grants, praised the efforts of the city in working with local nonprofits to help acquire equipment that mostly supported helping to feed people, including Blessing Baskets, The Lord's Harvest and the Community Action Agency. The CAA helped people with rental and utility assistance parks for the more than \$600,000 project. The contract is turnkey and comes with a 25-year warranty.

The company, Musco Lighting, has installed lighting in Oklahoma for entities such as the Bricktown Ballpark and Oklahoma State University. Funding for the project is coming from the royalty fund produced through mineral leases.

Sandidge said the current lights are not adequate and it's difficult because of the age of the system to find replacement parts.

• A contract with Lone Hickory Cattle for waterline work at SH 66 and U.S. 81. The \$760,465 contract is part of the construction for the roundabout that will be built there. Sandidge said financing is from the Oklahoma Department of Transportation in the form of a 10-year, 0 percent interest loan.
