

Community leader remembered

When people talk about Carl Morck, one of the first things mentioned is how much he worked to improve Green River.

Morck died at Memorial Hospital of Sweetwater County May 30 at the age of 81. He was a former member of the Green River City Council and served on numerous board and committees, including the Greenbelt Task Force, Sweetwater County Museum Foundation, Green River Historic Preservation Commission and

Sweetwater County Recreation Board.

"I grew up down the street from Carl and he was friends with my dad," Brie Blasi, director of the Sweetwater County Historical Museum said. "When I first moved back here, Carl was one of the first people who came by the museum to say 'hi' and reminisce about the neighborhood when I was a kid."

Blasi said he was a good friend to the museum and was a descendant of some of the earliest and historically-important settlers in Sweetwater County, the Gaensslen family, the Egg family and Tom Whitmore, the namesake for the city's American Legion post

Legion post.

"I think this was a big part of who he was because he really loved Green River and he felt a deep connection here," Blasi said. "He was a truly kind and caring man who was always willing to help, volunteer, and just

be involved in the community."
John Freeman, a founder of the
Greenbelt Task Force, also noted
Morck's willingness to volunteer.

Green River approves dog park

Green River's dogs will have a place to play after the Green River City Council approved a request to build a dog park last week.

The park was originally proposed by Green River High School's National Honors Society and will be placed at 80 East Teton Blvd., next to the city's animal control facility.

"I'm really excited to see a dog park go in because I've been to the dog park in Rock Springs and it just looks like a load of fun for the dogs," Councilwoman Lisa Maes said.

Brad Raney, director of the city's parks and recreation department, said the maintenance would go to his department, but said the rules and

other regulations would likely be set by a volunteer committee, similar to how the city's horse corrals are managed.

Victoria Hemphill, the NHS advisor at GRHS, said the group originally suggested the park to city representatives three years ago. After several meetings and fundraisers, a public hearing last year and a planning and zoning meeting, she said they were finally able ask the Council to consider building the park.

Roryanne Ratliff, president of NHS during the 2020 school year, said the group wanted to create a lasting gift to the community.

They decided to name the park after Mike Brown, who Ratliff said stepped up and helped the group move the park project forward.

Attempt at 2020 rodeo made

High School rodeo will not be in Wyo.

Weeks after announcing it would limit the Sweetwater County Fair to 4-H and FFA events and the cancellation of the Red Desert Roundup Rodeo, the Sweetwater County Events Complex announced it was seeking the 2020 National High School Finals Rodeo.

Ultimately, the rodeo committee decided to host the event in Guthrie, Okla.

""We are thankful that the National High School Finals Rodeo has found a home for 2020. We appreciate the positive feedback from the community and wish we had better financial news," Larry Lloyd, executive director of the events complex, said in a release Friday.

Lena Warren, the marketing and event coordinator for the complex, said more than 40 were cancelled due to the coronavirus pandemic, costing the complex approximately \$1.1 million in revenue. This decline has caused the complex to struggle financially, forcing Lloyd to seek a loan from the Sweetwater County commissioners to help float the organization until its next tax distribution.

The rodeo was originally planned to take place in Lincoln, Neb., July 19-25, but was cancelled due to the state's health restrictions.

According to the Gillette News-Record, representatives of the rodeo association contacted the Cam-Plex in Gillette to host the rodeo. Shortly after the News-Record published its article about the request, the Sweetwater County Events Complex announced it was also trying to secure the rodeo.

Warren said the complex would have worked with local and state health departments to ensure the rodeo would adhere to health guidelines. According to the News-Record, the NHSFR Association was circulating a plan it intended to follow regarding hosting its event and ensuring the safety of its participants.

"The Sweetwater Events Complex is a driving force that stimulates our economy year-round. Each event plays a key role in fostering tourism and economic development and the National High School Finals Rodeo is a perfect example of this," Lloyd said in the initial announcement.

While the complex has lost revenue from the cancelled summer events, those losses also impact local municipalities due to the loss of sales tax associated with those cancellations. The events complex hosted the rodeo in 2018 and 2019.

Woman pleads guilty to using dispatch funds for own use

ROCK SPRINGS (Wyoming News Exchange) — Laura Etienne pleaded guilty Thursday morning to using funds from the Sweetwater County Combined Communications Dispatch Center to buy nearly \$3,000 worth of personal items between 2016 and 2018.

She and her husband Robin Etienne, former director of the Combined Communications Dispatch Center, were both arrested in January 2020 and charged with felony and misdemeanor counts related to misusing an Amazon Prime account set up for the center and making nearly \$7,000 in

combined unauthorized purchases. The couple currently lives in Utah. Laura Etienne originally pleaded not guilty to the felony theft charge at her arraignment in Sweetwater County District Court early in March. Her change of plea Thursday morning in District Court was part of an agreement with the state of Wyoming.

Judge Richard Lavery accepted Laura Etienne's guilty plea at Thursday's video hearing. She will be sentenced following completion of a pre-sentence investigation. The plea agreement recommendation is a two- to four-year suspended sentence at the Wyoming

Women's Center, three years of supervised probation, and restitution in the amount of \$2,955.16 plus court fees. Once restitution is fully paid, probation would be modified to unsupervised. The restitution amount is Laura Etienne's portion of the unauthorized charges.

Acknowledging that she had no authority to use the credit card, Laura Etienne told the court she had no reasonable explanation for having done so. She said the credit card was saved on the family's Amazon account, and she would select it at times when making personal purchases.

"He was genuine. There was nothing phony about Carl Morck," she said.

Mayor Pete Rust said he would work out at the same time as Morck, specifically speaking about Morck's ability with the speed bag.

Rust said Morck was a good friend and supporter to his mayoral

campaigns.
Rust said one of the aspects that stands out to him the most is how much Morck worked for the community and the diverse number of groups

he was a part of.

"Carl was the epitome of being in local government to help your community," Rust said.

"Nobody did it better."

More polling places added

Curbside voting will be available during the elections at the Sweetwater County Courthouse.

Residents are also able to vote using an absentee ballot, which can either be mailed or dropped off, or make use of an early vote center at the county courthouse starting July 13 until Aug. 17, from 8:30 a.m., to 4 p.m.

of Green River, Wyoming. He was born on July 6, 1938 in Green River, Wyoming, the son of Carl M. Morck and Allice

Whitmore-Gaensslen.

Carl attended Lincoln High School and graduated with the class of 1955. He then attended the University of Wyoming where he received his Bachelors and Masters Degrees. He later received his PHD in 1973 from the University of Utah.

Dr. Morck was a professor at Western Wyoming Community College. He also worked for the Bechtel Corporation and the Green River Recreation Center.





ur view: Be careful around the river

Despite a few days of cold, spring-like weather in the last few days, summer is quickly approaching in Green River. With that, summer activities on the river itself are becoming an attractive past time as well. While we're in favor of a fun afternoon in the river, it's also the time of year everyone should be careful

June typically means more spring runoff flowing unto the Fontenelle Reservoir, which also means releases from the dam will increase. In fact, increased releases started Monday, with the dam increasing its release from 1,780 cubic feet per second (cfs) to 3,180 cfs as of this publication.

This means the river is flowing faster and is deeper

than it was last week.

The Green River's emergency services have

already responded to reports of people being swept downstream and while those incidents ended in the best way possible, the wrong combination of safety equipment, swimmer ability and increased flows from the dam could end in tragedy. Thankfully, it's a tragedy the community hasn't experienced in some time, but the possibility is always there.

We're not advocating for complete avoidance of the river. There are still a number of activities to enjoy despite the increased flows.

We're urging caution and careful planning to those who decide to enjoy what the Green River has to offer. The last thing anyone wants, us included, is to experience a tragic day stemming from an incident at

Millions of Americans are concerned about the continued impact the coronavirus pandemic will have on our economy.

As a result of the pandemic, hospitals and frontline workers nationwide are at the forefront of this fight both from a healthcare perspective and from an economic perspective. Memorial Hospital of Sweetwater County is no excep-

Congress approved \$175 billion in emergency provider grants, but not enough to prevent a deepening crisis. Hospitals alone will lose more than \$200 billion through June, according to the American Hospital Association. Continued summer losses will continue into fall/winter as COVID-19 returns

with the flu season. Congress has the opportunity to avert a healthcare crisis this fall by forgiving the \$100 billion federal COVID-19 loans that providers accessed in April. The federal CARES Act assured providers COVID-19 costs can be reimbursed, including lost revenue. Providers will spend loan dollars only on pandemic costs. Without forgiveness, loan repayment starts in September for the \$100 billion. Memorial Hospital of Sweetwater County's loan allocation of \$7.4 million is included. Loan forgiveness will support our providers and staff on the frontlines, and keep our doors open, which is vital for our community. Please help the frontlines by telling your U.S. Representatives and Senators to pass loan forgiveness now.

Simply put, loan forgiveness for our hospital, and others across the nation, will ensure that quality care continues in our community.

Our frontline heroes need Congress to act and pass legislation to forgive the loans to hospitals.

Have vou ever been afraid because of the color of your skin? Have you ever been afraid based on ethnicity and even religious beliefs? I spent all morning visiting with a young man with an ethnic descent and we discussed an environment that I was aloof to.

This young man has experienced difficulties due to his ethnical descent and shared experiences that caused me discomfort and awe. This even in our own county. This is a prerequisite to what I have to offer.

I received a phone call from San Antonio, Texas. I do not know anyone there and have never been there, though the message stated that there is a warrant for my ar-

Naturally, understanding that I have not done anything wrong, nor have I been to Texas, nor have I encouraged anything illegally that caused me to think if I had done anything wrong. That being said, I was curious as to why there would be a warrant for my arrest.

So, I blew it off, however, my wife felt like it should be reported. So, she called the police depart-



ment to report the incident in an effort to make sure or clear my name, or just find information. This is where the story begins. After calling the Green River Police Department, I shared this story and an officer was dispatched immediately.

In about 10 minutes, there was a knock on the door, and it was an officer from the Green River Police Department. He told us his name though I cannot remember with all that has been presented publicly, it is hard pressed to trust our public representatives.

He was kind and we invited him in. With his training and through protocol, he expressed true value and leadership in his endeavor to answer and follow protocol. We asked him to sit down, he said: "Thank you, but no."

He stood by cautionary and a value that I would expect and encourage in those that have dedicated themselves to uphold the law.

Our question was simple: "Am I a villain? Do I have a warrant? Has somebody done something in my name that I need to know about?' This comes from an awareness of identity theft and how it can mess up your whole life. This did encourage our response to get the police involved.

Back to the story, a young police officer knocked on our door, courageous, and ready for what he might encounter.

The Staycationer's Guide: Driving the wild horse loop

Flaming Gorge Days is cancelled. Mansface Mountain Music Festival is cancelled. Sweetwater County Fair, with the exception of 4-H and FFA events, is also cancelled.

It's understandable that people are wanting to get out of their homes as the summer months start and, also understandably, might be wondering what they can do as almost every major summer event in the county has been cancelled.

We're here to help. There are countless excursions and adventures waiting for people just outside of town. Over the next several weeks, we will highlight some of these outdoor excursions.

Some of Sweetwater County's adventures can be enjoyed in just a few hours. One of these treks is along the Wild Horse Loop Tour. The loop is a 24-mile tour along the top of White Mountain, most easily accessed from Green River through Wild Horse Canyon, past the Hampton

People undertaking this adventure are treated to some of the most breathtaking scenery Sweetwater County has to offer, some of it not even a mile into the journey. Traveling through Wild Horse Canyon offers an opportunity to view some of the large rock formations the area is known for, with the towering structures visible from either side of the road. Upon climbing to the top of the hill, the scenery changes from rocky terrain to the vast expanses and open vistas of the high-altitude

desert. Along the left side of the vehicle, Pilot Butte can almost always be seen throughout the duration of journey, while the right side of the road provides an excellent vantage points to view both Green River and Rock Springs, as well as tremendous portions of the Southwestern Wyoming landscape.

Along the route, interpretive signs inform visitors of local landmarks and the geologic history of the area, shedding light on how Lake Gosuite formed the landscape we call home. The route also provide an excellent opportunity to see the county's flora and fauna, with many species of birds, flowers and plants easily viewable from a vehicle.

Of course, horses are the main feature as the loop gets its name from the herds living throughout the area. They can sometimes be seen feeding close to the road or walking along it.

Photographers can have a field day along the loop tour, especially during the golden hour in the mornings and evenings where softer sunlight highlights landscape. Portions of the area also makes for a great backdrop for DIY photographers planning graduation or family photos in front of Pilot Butte or the land-

While much of the route leading to Rock Springs is a mixture of dirt and gravel, the portions near the entrance at 14-Mile Hill are rutted and in need of repair. While a passenger car could navigate the route, drivers are cautioned to slow down and drive carefully to avoid, at very least, jostling the contents

A car was left abandoned at the side of the road, near 14-Mile Hill. It's windows were shattered by the stones I found inside the vehicle. It's tires were flattened and oddly enough, a county 19 license plate was still attached. An impound sticker was on a portion of the back window, but was so weathered and faded it was impossible to read -whatever was written on it had long since vanished.

Anyone who ventures along the dirt roads and two-track trails in Sweetwater County has seen trash piles lazily left to rot in the desert

sun. Couches, appliances and entire vehicles aren't unusual sights in the desert. It doesn't take long for those objects to attract bullet holes and other signs of abuse -- sometimes

from the same people who dropped them off in the first

Why is that? Is it due to the imagined cost of taking something to the landfill. Is it laziness? This isn't an isolated issued, it's something widely seen throughout the county. For all the outdoor recreation groups like Sweet-

water County Travel and Tourism and the cities' chambers of commerce promote, it comes across as a tremendous eyesore for anyone wanting to view the wild horse or some of the otherwise breathtaking scenery we have in our backyard.

The county's land use department used to host annual cleanup days to

help mitigate dump sites throughout the desert. These efforts would yield several tons of refuse and feature a wide-ranging spectrum of various items.

The county also used to host a bound program where residents could earn a reward for reporting someone dumping their trash on county lands.

Both the cleanups and bounty program ended years ago, but we shouldn't rely on county to take care of the problem.

As Green River gears up for its annual City-Wide Cleanup week, perhaps we should pay attention to the lands outside city limits and pick up the garbage carelessly left by people who seemingly can't be bothered to get rid of it any other way.

It would go a long way in helping promote the beautiful vistas and outdoor opportunities we take for



80 Years Ago

June 7, 1940 **East End** "Excessive **Noise" Drives Residents To Protest**

East end residents of north Green River complained to the City Council Monday that the noise and clamor resulting from softball games and the loudspeaker system from a cafe opposite the softball park were constituting a decided nuisance. A request was made by the residents that some action be taken to tone down the disturbing factors, particularly after 9:30 p.m.

In accordance with the City of Green River Code of Ordinance, Appendix B, Section 10.7, signs of any political party or signs announcing the candidacy of any individual for nomination, are allowed to be displayed without obtaining a permit, provided:

- 1) That the sign(s) do not exceed thirty-two (32) square feet;
- That the property owner has consented to the placement of the sign(s) on their property; and,
- That the sign(s) are removed within ten (10) days after the election for which the sign is intended.

In addition to the specific requirements for political signs, the City has received questions about the placement of political signs on City owned property and within street rights-of-way generally the area between the private property owner's fence and the public street, and includes City maintained green space). The City of Green River Code of Ordinance, Appendix B, Section 10.4.C.1, lists "signs located on public property" as prohibited, therefore, all signs (including political signs) located within publicly owned street right-of-way, or other properties owned by the City, are not allowed within the City of Green River. Signs that are found to be located within a street right-of-way or on other City owned property will be removed by City staff.
