### Raburn elected mayor by wide margin

On Saturday, May 4, Ennis elected a new mayor in 29-year-old Kameron Raburn. The race between two for-

mer city commissioners projected Bill Honza, 53, as the establishmentbacked probable favorite against Raburn, an up-and-comer. By a margin of 60.2 to 38.7, Raburn

won by a 1,071 to a 688 count. He had a similar wide margin in early voting, 60.3 to 38.5, or 717 to 458. Write-in candidate Jeremy French finished a distant third.

"I am honored to have been elected to serve as the next Mayor of the City of Ennis," Raburn said on social media. "I want to express my deepest gratitude to all the voters who put their trust in me and supported my campaign. I promise to work tirelessly to make our city an even better place to live, work, and thrive."

The mayoral race was one of seven positions on the local ballot, three of

retain a position.

Incumbents John Erisman, in Place 4, and Bill Chapman in Place 5, easily kept their role as a trustee on the EISD school board. There was one other battle, and it was for a trustee of Place 3.

An officer on the board with a long stronghold, Walter Beasley, announced his retirement after 27-years of service. The seat for the amicable Beasley, was succeeded by Wayne Leaks. He garnered a 60 to 40 percent victory, or 1,053 to 706 of the tabulated ballots over Michael Scott.

### **City Commissioners**

Three City Commission seats were up for a vote, with the current occupant in Ward 1, Rowdy Pruitt, bagging all 146 votes to win another term. He ran unopposed.

Then there were three-person battles for representatives for Ward 3 and Ward 5. Raburn and Honza previously

them featuring uncontested bids to held those positions, by rule, they had to resign in order to run for mayor.

> Scott Hejny (HAY-nee), who had served as a commissioner in the past, picked up 63 percent of the votes to win over Trevor Wilhoite (31 pct.) and James Wilson (6 pct.).

> The Ward 5 seat that Honza held, now belongs to Dr. Eric Pierce, whose 51 percent was enough to topple Pete Setian (29 pct.) and Ariana Campos (20 pct.). It was the closest of all races.

### **Voter turnout**

Typically, the turnout at spring elections is considerably less than others. While the numbers were down overall in the county, Ennis doubled the count of the county.

There are 141,505 registered voters in Ellis County, of which 11,642 participated by voting. That is 8.23 percent.

In Ennis, however, with a population of 25,000, of which 11,000 are registered voters, those handing in



### Artists compete in painting outdoors

### Waxahachie hosts event, show on May 25

Artists from as far away as the Netherlands and as local as Ennis will set up their easels in Waxahachie during the Ellis County Art Association's Annual Paint Historic Waxahachie Plein Air Show May 17-24. The annual competition of painting outdoors has been sponsored in Waxahachie for 17 years and attracts artists from all over Texas, as well as California and Nevada.

"Not only is this a great experience for our artists but it's also great for Waxahachie, too,' Patti Holloway, event coordinator and vice president of ECAA, said. "This is the only time that Waxahachie is flooded with this outstanding artistic talent and then the public has an opportunity to purchase a one-of-a-kind painting."

Paintings must be finished outdoors and most artists hurry

to finish before the light changes. Because of this, many of the paintings are smaller in size and display a looser style, similar to the impressionists.

Each artist may hang up to five paintings so there will be lots of choices for the public. There will probably be paintings ranging from the architecture of Waxahachie including the gingerbread houses and the courthouse, to flowers, landscapes and other interesting subjects the artists find.

Artists who registered for the event were also eligible to paint anywhere in Ellis County during April 19 through May 3. There were 32 artists painting around Waxahachie last year and there are over 40 registered for this vear's event.

Claudia Parsons, artist from Waxahachie, was last year's winner. She painted a watercolor of a house in Waxahachie.

"I have entered this event for many years now and was delighted that I won last year," Parsons said. "Plein Air has always been an exciting, challenging and fun time."

Other well-known award winning artists participating are Kent Brewer, Bruce Peil, Henry Prikryl and Tina Bohlman.

Over \$8,000 will be awarded to the participating artists. The juror for the awards is Patrick Saunders, award-winning artist from San Antonio, who is also leading a workshop.

After painting May 17-24, the paintings will be on display and for sale at The Hamilton at Garden Valley in Waxahachie. The exhibition will be open to the public Saturday, May 25, from 10 a.m. to 3 p.m.

# This recipe makes for a great breakfast in bed this Mother's Day

There's no shortage of breakfast in bed options to serve Mom this Mother's Day. If Mom loves a traditional hearty morning meal, this recipe for "Mixed Berry French Toast" courtesy of Taste of Home (tasteofhome.com) is sure to please.

### Mixed Berry French Toast

Makes 8 servings

large eggs 13/4

cups fat-free milk teaspoon sugar

teaspoon ground cinnamon 1

teaspoon vanilla extract 1 teaspoon salt

1/4 1

loaf (1 pound) French bread, cubed package (12 ounces) frozen unsweetened

1 mixed berries

2 tablespoons cold butter 1/3

cup packed brown sugar Confectioners' sugar and maple syrup (optional)

Whisk together the first 6 ingredients. Place bread cubes in a 13 x 9-inch or 3-quart baking dish coated with cooking spray. Pour egg mixture over top. Refrigerate, covered, 8 hours or overnight.

Preheat oven to 350 F. Remove berries from freezer and French toast from refrigerator and let stand while oven heats. Bake French toast, covered, 30 minutes.

In a small bowl, cut butter into brown sugar until crumbly. Top French toast with berries; sprinkle with brown sugar mixture. Bake, uncovered, until a knife inserted in the center comes out clean, 15 to 20 minutes. If desired, dust with confectioners' sugar and serve with syrup.



### Stubby is gone

It may be that Stubby is gone

In the summer of 2022, I started writing about my mother's new pet, a red squirrel who she reluctantly began to care for.

My parents live on 20 acres in the woods up north in a house my father designed when he retired 35 years ago. The house looks over the lake and, for most of the win-

ter, my parents have few neighbors, except for the birds at their feeder and the deer making their way through the deep snow and, of course, red squir-

Red squirrels are not friendly, like chipmunks. They are more rascally than gray squirrels. They are timid around people and aggressive around other squirrels and they will eat all the bird food they can get their paws on. My mother was not a fan of red squirrels.

But when one particular red squirrel began hanging around my parents' house, my mother began to reconsider. Their relationship got off to a rocky start when the red squirrel tossed pine-cone seeds on my father's head and dug up my mother's flowerpots and made a terrible mess of the deck.

But, after the mysterious loss of his tail, my mother began to feel sorry for this little scoundrel. She began to leave him a few seeds on the railing. Eventually, the red squirrel, who we decided to call "Stubby," became quite attached to my mother, and would stand with its little paws knit together, looking into the window after my mother left seeds out for him on the railing.

Stubby now appears to be missing.

There is another red squirrel and, as hard as my mother would like to believe otherwise, it is not Stubby.

"Could it be that his tail has grown back?" my mother asked.

I'd heard of salamanders growing new tails, but this seemed unlikely in a red squirrel. We both stood silently at the window for a long time, trying to convince ourselves that this was Stubby -- thinner after the long winter, with a new scar on his side and a much longer tail. But we knew it was not

"I saw two squirrels chasing each other around," my mother said. "I thought one of them was Stubby. Do you think this squirrel chased him away?"

Of course, I didn't know. I didn't even know how long red squirrels lived. Three years, I later learned, is average, although some have lived up to 10 years in captivity. But even with a steady supply of seeds, I don't think Stubby was living under optimum conditions. Somebody had already gotten the end of his tail, after all. And we have no idea how old he was when that happened.

"Where could he have gone?" my mother wondered aloud.

We do not know, and I don't suppose we ever will. I had hoped Stubby would be around this summer, tossing more pine-cone seeds onto our neads and peering earnestly at my mother through the window. I would like to believe that, after an extended convalescence, Stubby was well enough to seek out new territory, perhaps find a mate, start a new life with his refashioned tail.

But I know that none of this is likely. And it

makes me sad.

Stubby was a good friend to my mother. He made a big impression with his short life and his short tail and his surprisingly courteous manners. He was a fine example of how we can rebound from tragedy, make new and unexpected friends and behave better than people expect.





### Bulldogs (21-6-1) prevail, 3-0, to advance in playoffs

Ennis baseball fared very well in the arms race against McKinney North (21-6-1). Swinging the bats was where the Bulldogs gained just enough of an edge to eliminate the Lions, 2-1, in the best-of-three playoff series.

Still, North's senior-laden squad overcame a scrappy Ennis (17-14-2) team that brought the fight to the favored 'Dogs.

Playing short-handed, with two starters out due to injury and another having quit the team headed into the playoffs, the Lions were noticeably undermanned.

As a result, No. 3 pitcher Caleb Beauchamp was out with an ailing hip, and the No. 2 hurler no longer available, Pitching Coach Chris Lewis called on catcher Ryan Todd and centerfielder, Gracen Harris, to take the mound. They allowed only eight runs in 21 innings, half of them unearned

Sophomore RHP Keno Castillo went the distance and allowed just four hits in a 2-0 loss in Game 1. Todd got the nod in Game 2 at McKinney. He yielded four hits in five innings before the Lions rallied for a stunning, 5-3 road win. Harris earned a save.

In last Saturday's decisive Game 3, played at Duncanville, Lewis sent Harris to the hill for his first-ever start. Like Sergeant Schultz, North "knew nothing" about Harris. He mixed speeds and battled through five innings, permitting one earned run on just two hits.

"Gracen stepped up in a big-time situation and threw the ball really well. He gave us a chance to win," said Coach Lewis. "He competed with his fastball, in-out-up (inside, outside, up high) and mixed in a curveball and changeup for strikes. They kept North off-balance. He did exactly what we needed him to do for us to have a chance to win - throw strikes and get outs. Couldn't be prouder of his performance."

Freshman Kevin Rodriguez tossed the last two frames and permitted a run in each on three hits and two walks.

Ennis was again shutout in a 3-0 setback, the seventh time they were blanked during the season, six of them occurring in the last 13 games. The Lions scored in only 2-of-21 in-

nings in the series.

### **Full Nelson**

In the season finale, they faced sophomore Brooks Nelson, 6'1, 185, the Bulldogs top closer. They had three scoring chances – in the first, third and fourth innings, and failed against Nelson. Now 5-2 with three saves, he escaped and over the final four innings he was hitless.

Getting to a pitcher early is critical, for once they get into a groove they are tough and confident.

Todd blasted a two-out double in the first, which was followed by a walk to Cannon Montelongo. A groundout to first ended the threat.

In the third, Keno Castillo singled sharply on the first pitch. Blaine Zhanel did likewise, hitting a looping liner, also to rightfield. The golden opportunity disappeared in one play. Todd lifted high fly to shallow rightfield. As it drifted into foul territory, it was caught over the shoulder by the first baseman. The two baserunners tagged to advance a base. The North third-baseman caught the ball and threw back to the shortstop, whose tag-out completed a rally-killing double-play.

The ensuing inning had two runners on base (infield error and a walk) with two outs when a grounder to second base left them stranded.

### Thrilling Finish

Odds of extending the season to a Game Three in the playoff series appeared doubtful last Friday in McKinney. But no one bothered to tell the Lions, who are very young and, trailing 3-1 in the seventh, roared to snatch victory from the jaws of defeat. A stunning four-run rally evened the series at 1-1, and set up a rubber-match to determine who would advance to play Lufkin (24-7) this weekend.

HC Kellen Monreal, known for assembling some wins out of a pile of Ikea pieces, did it again. His crafty Lions, with only three seniors in the line-up, play defense and pitch well, manufacture runs by working the count in their favor, advancing baserunners with bunts, and stolen bases to create mojo, especially when their bats are hexed.

Ennis rapped 10 hits, most of them off of Baylor-commit, LHP Jack Garza. Keno Castillo had two of the hits, a double and a triple, and Blaine

### Gilkey making the grade at UTSA

### Former Ennis QB is a redshirt Freshman

Ennis alum Jackson Gilkey, who earned back-to-back district MVP honors two years ago, was named the football player at (NCAA Division I) University of Texas at San Antonio with the highest grade point average. Gilkey, 6'3, 220, was rewarded as an All-Academic athlete.

The son of parents Tim and Shara Gilkey, has one sister, Molly. He is majoring in business management. His dad played football for the Wisconsin-Oshkosh Titans.

According to the UTSA website, Jackson passed for 5,725 yards and 51 touchdowns at Ennis. His pass completion percentage is 64 percent, hitting on 387-of-605 attempts, which earned him a QB rating of 170.06. His reportedly trails only Graham Harrell in the program's passing records. Gilkey also ran for 884 yards and 12 TDs on 155 carries while at Ennis.

Under Gilkey, the Lions won district titles, including an 11-1 record as a junior. He was a three-star prospect by 247 Sports and Rivals, though Dave Campbell's Texas Football listed him in the Texas Top 300 and rated the No. 10 QB in his senior class.

Currently, Gilkey is a redshirt Freshman with the Roadrunners, who posted a 9-4 mark a vear ago. They went 11-3 in 2022.

UTSA opens the 2024 season on Aug. 31 when they host Kennesaw State (Ga.), and follow that game with a Sept. 7 versus Texas State and Sept. 14 at Texas.

Gilkey hopes to battle for a spot in the QB mix, though insiders point to Eddie Lee Marburger, a Redshirt-Junior from Sharyland Pioneer HS and Owen McCown, a RS-Sophomore, who transferred from Colorado, as having the lead. Frank Harris, the former starter for the Roadrunners in recent years, has graduated. He was not drafted by the NFL in April.

Jeff Traylor is 39-14 as the HC at UTSA, after being hired away from Arkansas.

Meanwhile, the Ennis dugout resembled the monkey exhibit at the zoo after someone rattled the cage-bars with a stick.




