After a few months of making the drive, the duo arrived one day to see the gates closed and the track no longer open. After some persuasion from his young son, Jandebeur said he made a phone call. Twelve years later, the park is known across the country and is busier than they have ever been.

"Even with the pandemic last year we still hosted approximately 50,000 guests," Jandebeur said. The park offers visitors a way to get out of the house and experience the great outdoors while staying socially

The motor sport park boasts 10 dirt tracks, two biking or hiking trails, as well as a mechanic on site and a clubhouse where guests can rent dirt bikes or purchase needed gear.

Guests do not have to know how to ride to visit the park.

"I have taught over 3,000 to ride over the years," Jandebeur said.

Anyone interested in taking a riding class can contact the park to schedule an appointment. The class is typically an hour long followed by an hour of practice riding.


Water issues in Okmulgee County municipalities and rural water districts are gradually improving.



# Mt. Zion Baptist Church serving community for 101 years

Okmulgee County is home to many churches. Some have memberships in the thousands, whereas others may only have a handful.

However, each strives to fulfill their mission - being a place where people feel love, accepted and forgiven.

The Mt. Zion Missionary Baptist Church was founded in 1920 by S.F.J. Davis. It has 101 years of continuous service and is currently located at 1500 N. Miami Street.

Over the years, several men have led the congregation including Rev. Massey, Brown, King and Hatchet.

The current pastor is Dr. Douglas M. Currington Sr., who assumed the role after the retirement of Rev. David Burks, long-time pastor.

There are approximately 65 active members on the church roll. Other leaders of the church include Thessaly G. Griffin, Chairman of the Deacon Board; Galian Murphy, Deacon and Minister of Music; Deacon Charles Talton; Trustee Larry Mitchell, Choir President and Youth Department Director. A longtime deacon, Tommy Talton, recently passed away.

Mt. Zion Church and members keep busy with community activity including their jail ministry, which provides toiletries for the inmates and serving and providing Thanksgiving and Christmas meals to the local jail.

"We have provided food, clothing and other essential items towards community efforts," a church representative stated.

# Okmulgee's Black History

#### Area boasts unique towns, structures, events and people

Black History Month is a time to pay tribute to some of the wonderful, historic people who have given so much to move this nation along in incredible

Whether through inventions, politics, activism, science or philanthrophy, these individuals have left their mark in history.

We have already covered a few in the music industry and involved in sports and athletics, even though there are many more we may have missed.

In today's final part of the series featuring Okmulgee's Black History, we take a look at events, places and people known for their achievements.

#### Okmulgee's Fifth Street Commercial District

With Okmulgee's growth in the early 1900s, a full-service commercial district serving the black community came into existence.

From 1911 through 1925, brick buildings were erected in an area from the 300 to 700 blocks of East Fifth Street. The various shops and businesses offered many options for their clients.

There were shoe and clothing stores, general merchandise, grocery stores, tire shops, doctors, dentists, pharmacists, undertakers, barber shops and realtors in the area.

Residents could visit numerous restaurants, see a movie at the theater, and even visit a dance hall.

As time went along, more services were offered in the black neighborhoods located on the city's east side.

Several of Okmulgee's downtown buildings, including several still standing, were designed by black architects.

#### The Town of Grayson

Okmulgee County is home to one of the remaining All-Black towns in Oklahoma.

According to the Oklahoma Historical Society, from 1865 to 1920 African-Americans created more than 50 identifiable towns and settlements, with 13 still in existence in Oklahoma.

Formerly known as Wildcat, Grayson is situated in southeastern Okmulgee County. The town was named for Creek Chief George W. Grayson. A Grayson post office was established Feb. 10, 1902, and was discontinued April 30, 1929. By 1909, the small rural community boasted five general stores, two blacksmiths, two drug stores, a physician, and a cotton gin.

Currently, there are over 150 residents of the small town, whose mayor is Leon Anderson.


In October, the town hosts the annual Gumbo Festival, proceeds from which are used to assist the community with various projects.

#### Roy LeBlanc Okmulgee Invitational Rodeo

The second weekend of August, for the past 65 years, hundreds of competitors and thousands of spectators have come to Okmulgee to enjoy the Roy LeBlanc Okmulgee Invitational Rodeo.

Okmulgee's Invitational Rodeo is the nation's oldest African-American rodeo, one of the state's longest running rodeos and one of the largest African-American sporting events in the nation. On Saturday afternoon, visitors and residents line the streets of downtown Okmulgee for the annual parade featuring riding clubs, horses, marching and dance squads, motorcycles and cars.

The rodeo is held at the Bob Arrington

Arena at the Claude Cox Omniplex just west of the Muscogee Nation Complex.

Kenneth LeBlanc continues the legacy left by his father, Roy, after whom the event is named.

Besides Roy LeBlanc, other founders of the rodeo and the Okmulgee County Round Up Club included Ernest Thigpen, D.P. Lilly, Larnell Williams, Willie Tate, John Grant, Ernest Bruner, Clarence Williams, Charles LeBlanc and Alfred Nonnett.

#### Clarence LeBlanc

Clarence LeBlanc is well known for his rodeo skills. He was recognized by the International Professional Rodeo Association at a ceremony in Edmond last year.

LeBlanc was recognized as one of the Most Deserving Old Timers of the IPRA during their International Finals Rodeo's 50th anniversary event Jan. 17-18.

LeBlanc qualified for his first finals in 1976. He is a graduate of Oklahoma State University and joined the International Pro Rodeo Association in 1975.

He qualified for the International Finals Rodeo 13 consecutive years and was the IPRA's first black world champion.

LeBlanc also won the steer wrestling world title in 1983 and again in 1990, while claiming the national title in 1984. In 1988 and '89, he was the owner of the Steer Wrestling and Hazing Horses of the Year

He retired from competition in 2016.

#### **Melvin Morris**

Melvin Morris was born in Okmulgee, January 7, 1942. In 1959, Morris joined the Oklahoma Army National Guard and, soon after, joined the active duty United States Army.

Morris excelled in the military, becoming one of the first Green Berets in 1961 and twice volunteered for tours in Vietnam.

Morris received the Medal of Honor for his valorous actions on Sept. 17, 1969, while commanding the Third Company, Third Battalion of the IV Mobile Strike Force near Chi Lang, Vietnam. Then-Staff Sergeant Morris led an advance across enemy lines to recover the body of a fallen sergeant. Morris single-handedly destroyed, with a bag of grenades, an enemy force in a series of bunkers which was pinning down his battalion. Morris was shot three times during that engagement.

Morris received the Medal of Honor from President Barack Obama in a March 18, 2014, ceremony in the White House. The award came through the Defense Authorization Act, which called for a review of Jewish American and Hispanic American veterans from World War II, the Korean War and the Vietnam War to ensure no prejudice was shown to those deserving the Medal of Honor President Barack Obama in a March 18, 2014, ceremony in the White House Obama in a March 18, 2014, ceremony in the March 2014, cer

Morris retired from the Army after 22 years of service.

#### Okmulgee Black Hospital

The Okmulgee Colored Hospital, completed in 1922, served the African-American community from 1924 until it closed in 1957. It was listed on the National Register of Historic Places in 1984.

Leman Lewis purchased the building from the City of Okmulgee in June

Landmark for All Generations, Inc., was established that year with the mission to restore, rehabilitate, stabilize and preserve Oklahoma's first colored hospital.

Landmark for All Generations, Inc. is located at 210 N. Wood Drive.

"We believe this project will create a transformative and enduring impact upon the lives of all who inhabit and visit the Okmulgee community," Lewis said.

The structure will be used for a variety of purposes including an event center, business space and a multicultural center to preserve and promote Okmulgee's rich and diverse cultural heritage.


"Our mission is to bring the history of the former Okmulgee Colored Hospital to life for all generations," Lewis said.

The hospital is listed on Preservation Oklahoma's 2020 list of Oklahoma's Most Endangered Places.

#### William "Frank" Haygood

Though he was not born in Okmulgee, Haygood has very close ties to the area. Haygood was born in Cameron, Milam County, Texas, and was raised in the Tiger Flats-Sharp Community of Okmulgee County.

He was a baseball player, playing as shortstop, batting right and throwing

Around 1920, Haygood was good enough to be signed by a black team sponsored by the Okmulgee Merchants, who played at Petrolia Park. The merchants played many white semi-pro teams, but Haygood's fondest baseball memories were games against a tough club from Stroud, and the famed Kansas City Monarchs. As with most Negro Leaguers, playing against Satchel Paige

was always a thrill.

Haygood was a slick-fielding shortstop who hit for a high average and had excellent speed. Had he chosen to venture outside of Oklahoma, he would have been a good prospect to play in the Negro American League. Instead, he played most of his career with the Merchants, and several teams in the Texas-Oklahoma Negro League.

After retiring from baseball, Haygood owned his own plumbing company, but he couldn't completely give up sports. In 1955, Haygood and 10 other leading black Okmulgee citizens, started the first black rodeo.

Haygood died Nov. 21, 1983, in Ok-

# County high school students sought for Summer Arts Institute

Online auditions open through early March; all accepted students attend on full scholarship

High school students in Okmulgee County are being invited to audition for the Oklahoma Summer Arts Institute (OSAI) at Quartz Mountain.

Students with a variety of talents are asked to apply, whether it be in music, art, singing, dance, or creative

This year, the audition process will be held differently. There are 270 scholarships offered to attend OSAI, a two-week residency program. Auditions for the 2021 Institute are currently underway and are being conducted entirely online due to the continued rise in coronavirus cases. The program will still be held in person, but one month later than normal, July 10-25.

To be considered, students must complete a brief online application and submit audition materials demonstrating their artistic ability. The submission requirements vary from discipline to discipline. Performing artists and filmmakers will submit a video file. Writers and visual artists will submit a digital portfolio of their work. The application portal is currently open at apply.oaiquartz.org, and all auditions must be submitted by early March.

OSAI provides an experience far beyond that of an ordinary arts camp. Renowned teaching artists from across the country travel to Quartz Mountain, where

off, along with minor leaks at service lines within the city. Pressure reportedly held steady with the City of Ökmulgee water system all day Wednesday. The city representative reported that all customers in Rural Water Districts #1 (Schulter), and #20, now have some water coming to their home. Those districts began filling storage tanks again, which further boosted pressures in

their systems. Rural Water District #2 (Preston/ Beggs) worked on repairs to infrastructure damaged by the weather, and repaired a main that broke Wednesday.

Thank you to everyone that has continued to use water sparingly where service has been restored fully," the city representative stated. "We have seen usage drop consistently across the Okmulgee system over the last few days, which has allowed more water to flow to the rural districts."

Customers served by the City of Henryetta were encouraged to be diligent about repairing water leaks to ensure their water system continued to run effectively and efficiently.

As water service was resumed, several towns put out voluntary boil orders as a precaution. For their protection, residents are asked to bring the water to a full, rolling boil for at least one minute before drinking, consumption, food preparation, baby formula preparation, dish washing, tooth brushing, ice making, wound care, and bathing infants who may ingest bath water.

Thanks to all the water department and public works employees who have worked round the clock, many with over 100 hours in a week, to help get

the water systems back up and running. Also, thanks to coordination and assistance from the Muscogee Nation and Okmulgee County Emergency Management, along with businesses and churches who provided bottled water, along with water buffalos to aid in the distribution around the county.

Currently in Okmulgee, car washes are closed and several major manufacturers have curtailed their water usage to help the current situation.

Also offered at the new Academy will be adult education classes in drone operation, CAD, addition to being great and Industrial Manufac- this education path.

AOPA stands for Aircraft Owners Pilot Association; their "You Can Fly" High School Aviation Curriculum offers two pathways of learning - The Pilot Pathway and the UAS (Drone) Pathway. They began field testing the aviation STEM curriculum in 2017 and schools across the nation are finding that the program helps students acquire the skill necessary to enter the growing aviation industry. It is free to schools with the only requirement that teachers receive the professional development needed to teach the curriculum. The OAC has been working to increase the number of Oklahoma high schools choosing to implement

this curriculum. And LISTEN UP! Did you know that Okmulgee High School is one of only sixteen (16) schools out of the 537 schools in the state that are currently implementing the AOPA "You Can Fly" program. Okmulgee High School is the ONLY school in the state that offers the UAS (Drone) pathway. This shows some incredible vision and leadership at Okmulgee Public Schools to be at the forefront of

Coordina-Education tor for the OAC (who is also a long time educator in Oklahoma) said this about Okmulgee Public Schools efforts "I had the opportunity to meet with Okmulgee High School's leadership team in October 2020 and was so impressed with the goals that the school has set in regard to building quality STEM programs for students. Obviously, these have been difficult times for schools to be able to move forward with strong, innovative programs. It is clear to me that Okmulgee High School is working diligently to provide career opportunities for students. Aerospace is Oklahoma's second leading industry, and it is exciting to see that Okmulgee is doing the necessary work to provide viable career pathways for students."

Green Country Technology Center: Green Country Technology Center (GCTC) has also been part of discussions to develop a technical program to address aviation workforce needs in Okmulgee County. The proposed program would consist of Orientation and Overview of Aircraft, Aircraft Familiarization, Aircraft Powerplant, and Aircraft Electrical Systems. GCTC is currently in the curriculum development and exploration stage of this program; they are reaching out to local aviation industry partners asking for their input in building the curprogram is being con-

considered. Employment placement after completion is the most critical component but enrollment numbers must also justify a new program as well as the availability of qualified instructors. Further exploration of this program will determine the timeframe in which it could potentially be launched for Okmulgee County.

The WFED was awarded a Department of Defense (DoD), Office of Economic Adjustment (OEA) Grant to facilitate growth in the manufacturing and aviation sectors for DoD Contractors. Upon receiving the grant, the WFED staff formed the Industrial and Aviation Technology Training Center (IATTC). The IATTC boasts a strong advisory committee composed of members from the Okla-Manufacturers Alliance (OMA), a State Representative, leading manufacturers, and two aviation companies one of whom is a prominent international airline. 



Smiling cheerily, he wasted no time voicing a solution to my dilemma, "Would you like to go over to the other side?" Then, hardly taking a breath he added, "I can get you there..."

The youth quickly surveyed the Suzuki bike and waved an open palm, "and your piki-piki, too!"

Wary of the offer, I raised an eyebrow. "Come. Just come."

I clambered behind him up a muddy hill to a spot where we could take in more of the river upstream. I was not quite ready for the scene before me. At the water's edge lay a home-built canoe, long and narrow. Into the canoe was lifted a hefty bag of maize, the cargo of another traveler. What especial-

# **Things That** Last

We have heard it said, "All good things must come to an end." But, is this really true? The simple answer is "No, not "all" good things must come to an end." However, all of us have experienced some things in life we consider extremely good that came to an end and many of these brought great sadness. Some of these brought paradoxical emotions--both a feeling of loss for the past and an excitement for the door opening to future prospects.

Health is a good thing we usually enjoy for many years, but begins to change later in life. Most of us "older folks" can see a marked difference in our health from that of earlier years. We start off learning to walk and then we run. As times goes on, walking becomes a challenge for most of us. Our eyesight and hearing diminishes, our teeth become weak, our memory begins to wane and our hair turns gray or, for some of us, it just turns loose. You get the point, right? Woe and Whoa!

The good news is there are some things we find from the Scriptures that last forever and these doubtless are the most important. The first and foremost of these is our personal salvation from sin. In the all-time classic portion of Scripture in John 3:16, Jesus said He came to offer us "everlasting life." How long does it last? Jesus said "everlasting" which by definition means life without end, forever and ever.

From Ecclesiastes 3:14 we read, "I know that, whatsoever God doeth, it shall be forever: nothing can be put to it, nor anything taken from it: and God doeth it, that men should fear before Him." The devil, his demons nor anything else can rob us of our salvation. "... Greater is He that is in you, than He that is in the world (I John 4:4)."

A second thing that lasts forever is the spiritual food we receive from the Word of God. Jesus said in John 6:63, "The words I speak unto you, they are spirit, and they are life." During His temptation by the devil in the wilderness, Jesus said also in Matthew 4:4, "Man shall not live by bread alone, but by every word that proceedeth out of the mouth of God," and that Scripture is in the Bible for our admonition today as well.

A third thing that will last forever is the spiritual works we do for the Lord. In I Corinthians 3, Paul talks about building our life on one of two different foundations: "wood, hay, stubble" which will perish or "gold, silver, precious stones" which shall last forever. In Verse 14, Paul tells us, "If any man's work abide (lasts) which he hath built thereupon, he shall receive a reward.

Our Lord illustrated this truth in His parable of two men--one who built his life on the sands of time in this world and one who built his life on the eternal Rock which is the Lord Jesus Christ. The one on the sand did not last ("great was the fall of it") and the one on the Rock stood firm ("it fell not") (Matthew 7:24-27).







15-18 at the park and will include daily supervised riding, training, physical fitness, bike prep, riding skills, field events, adventure hikes on the trails as well as a lot of fun for the kids that attend. Camp classes are from 10 a.m. to 4 p.m. each day.

"Many riders come out and say they want to learn to jump," Bob says. "I have to tell them, jumping is easy; it's the landing they have to make sure they work on."

Dirt bikes are available for guests to rent if they want to ride but do not have a bike of their own.

"We also sell used dirt bikes as well as service the bikes here at the park," Jandebeur said.

The tracks at the park tailor to beginners as well as professional riders. During racing season, the park hosts a race every Friday beginning in March. Many of the riders that come to the park are from all over the Mid-West.



He said Okmulgee kind of reminded him of his hometown of Westville - small community to raise a family, lakes and ponds, hills and trees, much like where he was raised.

Of course, everyone (and even the hermits) have realized and experienced all the stressful events over

more than just the past year - COVID-19, political events, job losses, high unemployment, demonstrations, unnecessary loss of lives, forced isolation in many cases - they all begin to eat away at the fabric of our peace and contentment. Dr. Quinn says this is when we all need a good friend to talk with, including family, relationships, hobbies, church, clubs (such as Lions or Rotary), and not just sit and stew over things we can't change nor control, anyhow.

There are a lot of resources in Okmulgee to ask for help, such as Recovery Oklahoma, CREOKS, Creek Nation, Deep Fork, Oklahoma Department of Health (mostly bono), Anne Maroney Shelter and private counselors.

Dr. Quinn stressed the importance of couples communicating with each other, and as parents, reaching out to their children. It doesn't hurt to let them know they are loved even though all parties might be going through trying times. The old joke is told of the farmer's wife asking her husband why he never tells her he loves her. His reply was, I told you I loved you 40 years ago when I married you, and if I change my mind, I'll let you know.

What a very appropriate program, particularly at this time. To sum up Dr. Quinn's analysis, "what

doesn't kill you makes you stronger", and "we all are put on this earth to do something of purpose." Maybe yours is to give us a visit and bind together to make our club stronger.

Kaelem Carter chipped in seven points in the loss, while Tryton Mack rounded out the Dewar scoring with one point.



# **Comforting Casseroles**



Casserole, by definition, refers to the pan your food it is cooked in and then used to serve said food, from oven to table with one dish. Most often though, casserole is what we refer to as the food itself. In America and Europe, the casserole consists of meat and vegetables, diced to bite size pieces or shredded, and a binding agent such as potatoes or rice. A liquid is usually added in the way of beer or wine, stock or broth, or even cider or vegetable juice. These are most often topped with a generous layer of cheese or a crunchy breadcrumb topping and sometimes, both. Then, it is baked to golden perfection. According to Wikipedia, in the UK, Australia, New Zealand and Ireland, the casserole is named so because of the dish rather than the food. What they typically serve as casserole is what we usually call a stew. Instead of baking, theirs is finished on the stovetop and then served in the same

Casseroles are great when you don't think you have a dinner to throw together or even for using up leftovers from another meal. You can use any meat you may have on hand. Throw in a can or two of vegetables from the pantry and dice or slice up some potatoes and you can easily have a casserole. Need more liquid in it? You can add a can of soup like cream of mushroom or chicken or vegetable or chicken stock. Top liberally with cheese or even crackers and voila, instant dinner with easy clean up!

I love casseroles for the ease in cooking and clean up. Casseroles can be either side dish, main meal, or even dessert but are delicious either way. This week, I am looking at casseroles as the meal. Add rolls or Texas toast or even chips to any of these and maybe a salad if you are so inclined for a delicious well rounded dinner. Make your grocery list and meet me in the kitchen this week for recipes so easy to make, cook and clean up.



**Eggs Benedict Casserole** 

6 English muffins

Sirloin steak, thinly sliced. I used 5 steaks as I wanted plenty of meat. (they were on the small side)

- 2 ½ cups milk or heavy cream
- 1 tsp Worcestershire sauce 1 tsp onion powder
- 2 tsp paprika
- ¼ tsp salt ½ tsp pepper
- 1 pkg hollandaise sauce mix

Open English muffins and toast. You can broil in oven or use a toaster, whichever is easier for you. Cut 5 English muffins into quarters. Use last muffin to cut into smaller pieces to fill holes as needed. Place English muffins in bottom of 9x13" pan. Evenly layer steak on muffins. In large bowl, combine eggs, milk, Worcestershire sauce, onion powder, paprika, salt and

pepper. Gently spoon over English muffins and cover with foil. Refrigerate 4 hours or overnight. Remove pan from fridge while preheating oven to 350°F. Bake covered for 30 minutes. Remove foil and bake an additional 10-15 minutes or until knife inserted in the center comes out clean. Prepare hollandaise sauce. Pour over dish. Cut into squares and serve.

Note: Eggs benedict is traditionally made with Canadian bacon, but I can't have pork so I used steak. Feel free to use Canadian bacon if desired.

Pizza Casserole

¼ cup unsalted butter

1 tsp garlic powder

1 tsp dried basil

2 cups shredded mozzarella 2 cups Italian blend cheese

16oz cream cheese, softened ½ cup grated Parmesan, divided

2 tsps. Italian seasoning, more or less to taste

½ tsp crushed red pepper flakes, more or less to taste

½ tsp ground black pepper

34 cup pizza sauce, I used a 4 cheese blend pasta

2lbs ground turkey, cooked and drained, or other

pizza topping of choice

1 15.25oz package of pizza premade pizza dough Heat oven to 350°F and spray a 9x13" casserole dish with nonstick cooking spray. In large bowl, beat together mozzarella, cream cheese, 1/3 cup Parmesan, Italian seasoning, red pepper flakes and black pepper. Spread mixture evenly into prepared 9x13-inch dish. Spread sauce evenly over cheese mixture. Top with ground turkey. Sprinkle with Italian blend cheese. Divide dough into even sections. Roll dough sections into balls and place evenly over meat. Melt butter and mix in garlic powder and basil. Brush each dough ball with butter/garlic mixture. Sprinkle with remaining Parmesan cheese. Bake 35-45 minutes, or until pizza dough is golden brown and cooked through. Let cool 10 minutes before serving.

Note: I only used one package of dough but if you want the top completely covered, you will need two

**Chicken Squash Casserole** 

2 medium spaghetti squash, halved with the seeds

scraped out (about 2.5lbs each)

2 tsps. olive oil


Salt and pepper 1lb chicken breast

Salt and pepper, to taste

1 cup crackers of your choosing, crushed (Ritz are good here, but this time I used a cracker made of rice and I have also used almond crackers)

2 cans condensed cream of chicken soup

Preheat oven to 400°F and line baking sheet with parchment paper. Rub oil on inside of squash and sprinkle with salt. Roast, cut-side down, until fork tender, about 40 minutes to 1 hour depending on



size. Set aside to cool enough to handle easily. Reduce oven to 350°F. Bring medium pot of water to boil. Once boiling, add chicken and cook until no longer pink inside, about 12-16 minutes. Set aside to cool. Scrape spaghetti squash into colander in clean sink. Use hands or spoon to compress squash to remove as much moisture as possible. Place in large bowl. Shred chicken and add to bowl along with salt and pepper to taste. Add cream of chicken soup and stir everything together until well mixed. Once mixed, press firmly into 9x13" baking dish and cover with crackers. Bake until casserole is bubbly, about 45 minutes. Let stand 10-15 minutes. Enjoy!

#### **Oreo Casserole**

1 family pack Oreos, crushed

6 Tbsps. real unsalted butter, melted

8 oz. cream cheese, softened

1 cup powdered sugar

1 8oz container whipped topping, divided

2 3oz boxes instant chocolate pudding mix 10-12 Oreos, crushed into small pieces

3 cups cold milk

Topping:

Oreos, crushed

Chocolate chips, I used mini semi sweet and white

Lightly grease 9x13" baking dish. Mix Oreo crumbs and melted butter in medium bowl. If crumbs don't stay together well, add another tablespoon of butter. Spread evenly into bottom of prepared baking pan, using your hands or the back of a spoon evenly distribute. In medium bowl, beat together cream cheese and powdered sugar with electric mixer until smooth. Fold in 1 cup of whipped topping. Spread cream cheese mixture over crust. In medium bowl, mix together pudding mixes with cold milk. Stir in chopped Oreos. Allow to set just slightly, about 2-3 minutes. Spread over cream cheese layer. Spread remaining whipped topping pudding layer. Chill dessert in refrigerator for at least two hours. Top with more crushed Oreos and chocolate chips



Tips, Tricks & More from Your Local Professionals

This year, I went out and spoke with our local auto service shops for tips and advice on how to take care of your vehicle. I asked each one for a tip or advice or even something they see that people just don't do like they should. I enjoyed speaking with everyone and had some funny conversations. Ultimately, I compiled some excellent tips on caring for your automobile.

Gary from AutoZone said, "Don't wait until it's raining to change your wiper blades." It is recommended windshield wipers be changed out every 6 months to a year for optimum use. Some mechanics will check the wiper blades when changing oil. If you aren't sure, autumn is a good time to change them each year before the conditions get bad. This will get you through the winter and the rainy spring months with good wip-

There are several factors that can cause your wipers to be damaged. Age is the number one factor. Wiper blades are biodegradable and will simply wear down over time. How much you use them is another factor. Each pass of the wiper blades over the glass of the windshield breaks it down a little. They are made of rubber (unless you buy the more expensive silicone blades) and therefore are susceptible to the weather. Heat and cold cause them to expand and contract which weakens the material. Long dry spells can also cause problems. The rubber becomes brittle if too dry and the UV rays from the sun break down the rubber too. This all leads to breakage and wipers that are ineffective. There are some things you can do to

help your wipers last longer. First, never use the wipers on a dry windshield. If you have no washer fluid, spray or dump water on the windshield and then turn on the wipers. Clean your windshield every other month at the longest. Dirt and grime build up on the windshield if you only ever use the blades to try to clean it. That dirt and other hard stuck debris can cause the blades to catch ever so slightly and tear the blades. Use a dows. squeegee at a gas station next time you

fill up the gas tank to clean the glass. Cleaning the blades regularly with rubbrand new blades to need replacement. Always make sure the ice is defrosted before using the blades too. If you are in a hurry to defrost so you can go, use a saltwater solution or cool water mixed with rubbing alcohol to defrost the win-

wiper blades, there are things you can look for to tell you when they are in bing alcohol will also prolong their life. bad shape. Jerking motion or chatter-Frozen snow and ice can cause even ing noises occur when there are nicks and chips in the blade as the different parts travel unevenly across the windshield. Squeaking can also be indicative of damage to the blade. Random streaks of moisture or even spots that don't look like they were touched are a good indication of blade damage as well. If you have any of these issues, it's time to replace your wiper blades.

One thing to note, wiper blades are sold individually. While this may seem like a racket requiring you purchase more, some vehicles actually have different sizes on passenger side than the driver's side. My Chevy Sonic is a rather large difference. The driver's side is 26" while the passenger side is only 14"! So, pay attention when you buy, you may just need two different sizes.

Chris, also from AutoZone, said, "Don't drive on bald tires." The tread on your tires should not fall below 1/16 of an inch in depth. While you can purchase a gauge that will tell you the exact tread depth, it is far easier to use a penny. Yes, using a penny really can tell you whether you need new tires. Take your penny, with Lincoln's head down, and place it into the tread on your tire. If you can see his entire head, you need tires. Some tires have a built in indicator on the tread. Take a good look at the tires. There may be a flat bar that goes across the gaps in tread in a couple places. If that flat bar is level with tread, it's definitely time to get new tires. If you drive on wet or bad roads on a regular basis, it is suggested you double the rec-

ommended tread to keep you traveling down the road with maximum safety.

Low tread is not the only time you may need new tires though. Even vehicles rarely driven can have tires that wear out. Inspect the tires regularly to ensure they are still in good condition. Tires with cracks or cuts or bulges in the sidewall are going to give you problems. This is an indication the rubber is wearing out. You may have even hit something at one time that didn't cause damage you could see, but it may have weakened the side wall and, over time, it is wearing down. Sun and weather, in addition to driving hazards, cause weakening naturally as well. It's a good idea to just keep an eye on your tires for normal wear and tear of the tires.

Even if all of your tires look perfect and have plenty of tread, vehicle manufacturers recommend replacing tires every six years while some tire manufacturers recommend every ten years.

Doug at Daniel's Body Shop said, "Wax your vehicle at least twice a year to keep your paint job protected." Waxing is an important part of your vehicle's care. Vehicle paint is covered with a clear coat. Wax is applied as a kind of sacrificial layer over this clear coat. Everything from the sun's UV rays to bird droppings, from car wash detergent to sand and salt on an icy day are an assault on your vehicle. The wax is in place to give your car a type of 'force field'. However, just like in Star Trek, the 'force field' can be damaged and worn down. In order to protect the paint job, and the resale value, the wax must be reapplied regularly.

But how often is it needed? Some manufacturers recommend it every 3 months, like changing the oil. Some wax products themselves say it's only needed every six months. Environmental factors as well as use all make a difference though so it's not like you can just mark it on a calendar. Although if you need the reminder, go ahead and mark it down every three months. This barrier on your car wears down each and every

day, especially if you have no garage in which to store your vehicle. So, paying attention is the best way to know. Wax helps repel the water so beading should occur on a waxed vehicle if you pour water on it. If there is no beading, there is no wax left. Run your finger over the vehicle. A waxed vehicle will provide a smooth glide for your fingers.

So now you know you should wax, but there are so many products how do you choose and which one works best? There are five types of wax I found. Liquid wax pours from a bottle and dries quickly. If you are doing it yourself, this means you have to work quickly or work on small areas at a time. Typically these are made of synthetic polymers designed to protect from all the nasty stuff the world throws at the vehicle. It's typically a thin coat though and may need to be applied more often than the three months depending on the formula. Paste wax is thick and requires effort. You must work on small areas, applying a little at a time and buffing afterwards. This is recommended as one of the longest lasting though at 3 months. Polymer based wax is a solid wax much like the paste, but is made of synthetic materials like the liquid. Because it is a solid, it must be applied and buffed, but is said to take less time to apply than paste wax. The formulas seem to be different per wax though so it's hard to say how long this option will last. Carnauba wax is the traditional wax of our grandfathers. It is a natural wax made from palm tree oil. It is much like the paste wax in application, but is said not to last as long and may need to be reapplied more often as well. The last option is sealant. This is an entirely synthetic polymer-based solution said to produce a glass like finish over your clear coat. Sealant is liquid and claims to be easy to apply and last up to six months.

Debbie from Ausbrooks Truck Works said, "Never clean tinted windows with ammonia based cleaners." If it just needs dust wiped off, a microfiber cloth should do the trick. If you need a lit-



tle more due to the dog's tongue or the kid's sticky, messy hands, there are some cleaners specifically for tinted windows. However, all you really need is a simple mix of soap and water or even water and vinegar and a soft nonabrasive cloth.

Window tint can't be repaired, only replaced. Be careful with pets, kids with toys and even your seat belt dinging the window. Dirt or a loose gear inside the door can also cause scratches so inspect it regularly. If you do start seeing something show up, stop using the window until you can have the door inspected.

Seth from Kellogg's Firestone Service Center said, "Rotate your tires every 5,000 miles. You would not believe how many people just don't do this." Tire rotation is taking your existing tires and moving them to a new position on the vehicle, usually front goes to the back and driver's side goes to the passenger side. While this may seem unnecessary, this is crucial for maintaining your vehicle and it also can give you a clue to something wrong with alignment. Many tire manufacturers even require the rotation to keep the warranty valid.

Rotating your tires helps even out tire wear. The front tires work differently than the back tires on your vehicle, they also respond differently to the different driving conditions. By allowing every tire to work in each of the vehicle's four positions, which will be different with each rotation, you'll promote even wear across the tire tread pattern. Even tread wear is important for even and consistent handling and traction while driving. That helps with taking corners and braking as well. All in all it prolongs tire life. If you do have an issue with alignment or something rubbing wrong, this is a way to discover it before it gets too bad.

If you aren't sure when to rotate your tires or rarely remember it, do it at the same time you change the oil. The vehicle has to be off the ground for both anyway and 3,000 miles and 5,000 miles are close enough you can just do both services together.

Seth from Kellogg's Firestone Service Center also said, "Change your oil every 3,000 miles." The parts inside the engine move very fast. This creates heat and friction. Oil provides the lubrication to keep everything flowing smoothly. Without oil, the engine can overheat or even seize and quit working all together. The oil breaks down over time due to this friction and heat and that's why we must change the oil every so often. Think of oil as the blood in your vehicle. It must be flowing well and stay clean for the vehicle to run properly.

An oil change replaces the oil filter and the old oil in your vehicle. The oil filter is in place to remove contaminants from your engine. Over time, these contaminants would completely clog the filter not allowing it work properly. The contaminants, if they stayed in the oil and the engine would cause the engine damage over time. The oil is completely drained and then replaced. This removes any contaminants that may have escaped the filter.

Oil changes give you many added benefits as well. An oil change is the best way to save on gas. Clean oil helps the car run smoothly providing better gas mileage. It also keeps the engine, the heart of the vehicle, running well. Do it regularly and the engine may last longer than you want to keep the car. Fresh oil is also better on the environment. Old, dirty oil can produce noxious emissions and contribute to the deterioration of the ozone.

While 3,000 miles is a generic mileage given, different factors can determine when and how much you actually need to change the oil. Someone who drives 90% of their day will need to change their oil far more than someone who only drives recreationally on the weekend. Even an idle car needs to have the oil changed though. Too little driving can cause issues too and it's recommended that at least every 6 months the oil be changed even if you haven't made your 3,000 miles.

Doug from Quality Tire said, "Check all the fluids in your car regularly. If you commute more than 50 miles a day, do it every week. If you commute less, do it every other week." Checking the fluids is of utmost importance to the maintenance of your vehicle. It allows you to know your vehicle and can let you know if something is wrong. Brake fluid, transmission fluid, coolant or antifreeze and power steering fluid rarely need to be topped off but some evaporation can occur during use. Regular use can cause your engine oil to need to be topped off between oil changes too. The great thing is you don't have to guess. Most fluids have a dipstick with a guide for where the level should be sitting. While you are checking though, pay attention to the color of the different fluids and know what they should look like.

Power steering fluid especially gets dirty over time and will need to be flushed and replaced. This fluid will become cloudy with the dust and debris. If you are checking your fluids, you will see this. However, if you check your fluid and just feel like your steering just isn't working right, take it in to get checked.

Brake fluid gathers moisture over time and typically needs to be replaced every couple years. Low levels of fluid though would be disastrous to the brakes and your safety when driving.

If the coolant gets low, it can cause the engine to overheat as well. However, this should never be checked when the engine is hot. It can cause serious injuries. Always allow the car to cool before checking the coolant levels. While the car has sensors to tell you if the car is overheating, if you keep an eye on your fluids, you will already know if there is not enough in the reservoir.

Transmission fluid is important for

the shifting of your car between gears. Older cars have the dipstick and you can do it yourself. However, some newer cars no longer allow you to check this and a mechanic will have to do it for you. Some even more modern cars have completely sealed the transmission and it can't be checked at all. If you can't do it, then have the mechanic check it every time you have the oil changed. If you aren't sure which option you have, check with your mechanic or the dealership where you got your car or the car's manual.

Don't forget about your windshield

washer fluid either. This one will need to be regularly added for sure. Depending on how often you clean your windshield will determine how quick you run out, but if you are checking it regularly, you will always know if you need to add more.

If you start adding fluids once a week or even every other week, have your vehicle serviced. Something is wrong if you have to top off the fluids that much.

Rick from Rick's Muffler said, "When the check engine light comes on, get it checked sooner rather than later. Come see me, I'll run the diagnostics for free." The check engine light is just a sensor to tell you something might be wrong. It can be something minor like the gas cap not sitting well to something major like the engine misfiring and sending gas to the wrong places. When the car sends you the check engine light, it also stores the trouble code in its memory. When you take the vehicle to the mechanic, it's this code he reads to tell you what you need to fix.


There are some differences in some

cars though. Most older vehicles will only have a light that comes on and is just on until taken care of and reset. Newer vehicles though can give you different lights. Any check engine light that comes on red is an immediate danger. It is recommended you stop driving your vehicle and get it to the shop at once. A solid yellow or orange light is what you will most likely see and needs to be taken care of, but can probably wait until you can schedule an appointment in a week or so. A blinking light after it was a solid light can mean what problem you had (but haven't taken care of) is becoming more serious so get it taken care of. A check engine light constantly blinking without first being solid means you have an issue that needs to be looked at sooner than later and is fairly serious.

When the check engine light comes on, there are some things recommended you do. First, check everything you can just to make sure it's not something simple like low engine oil levels. Check your gas cap for a loose fitting too. You may need to reduce speeds or not carry heavy loads to ease the burden on the engine.

Some cars send data electronically once a month to a dealership auto service center of your choice. If your car does this, they will most likely already have the data on what issues you may be having. In this instance, you can call and schedule the appointment to have it taken care of or sometimes they will call you based on the information they receive.

Ultimately, it is important to know your vehicle and how to do some minor things to check it over to keep it running optimally. If you know how your vehicle sounds or feels when driving, you should know when something is starting to go wrong. Most importantly, keep up with regular maintenance and don't wait for repairs. Visit some of the shops around town and keep your vehicle running at max performance. When something is wrong, get it fixed immediately so a minor repair doesn't become a major issue.
