

Discussion over preparedness funds continues

Kaufman County has yet to spend any money and remains in a conceptual design phase with its architects in regard to the \$26 million in preparedness funding it received through the American Rescue Plan Act

(ARPA) of 2021.

The ARPA, which became law back in March, is a \$1.9 trillion federal spending package that includes \$362 billion to state and local governments and \$65.1 billion in direct aid to counties. The act was passed in response to the COVID-19

pandemic.

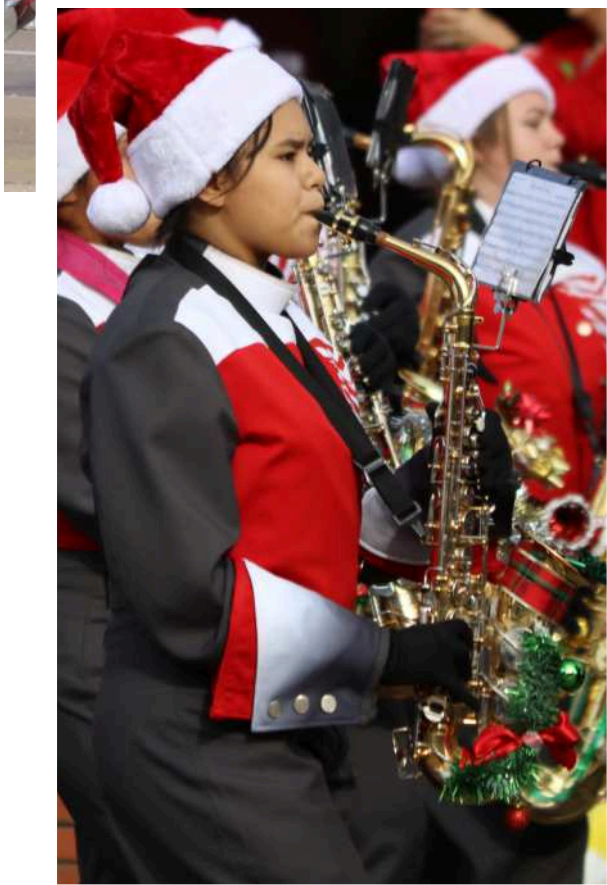
“At this point, the county is looking at expansions and renovations to existing buildings to mitigate the spread of COVID-19 to the public and our staff; however, we are still in the design/concept phase, working with our architects

through our Master Plan contract,” stated Donna Simmons, communications and economic development director for Kaufman County.

Simmons added that other than the design meetings, no money has been spent on the projects.

“We are working closely with our consultant Tidal Basin, as the commissioners look at finalizing plans.”

The county is maintaining a separate fund for the \$26 million that can only be for the intended purposes. The funds cannot be banked indefinitely.

CR 243 ribbon cutting set for Dec. 21

Transportation Bond Election. In that election, Kaufman County voters overwhelmingly supported more than \$104 million in road improvements, and many of those roads are in Precinct 3, which includes Terrell.

This ceremony will mark the second ribbon cutting ceremony this month of projects in Precinct 3. The first was held on Dec. 9 at

Colquitt Road and Samuels Road.

Terrell Mayor Rick Carmona and Terrell Chamber of Commerce President Carlton Tidwell will join Precinct 3 Commissioner Terry Barber and County Judge Hal Richards during the ceremony to recognize the commitment to delivering quality road projects while making the most of the bond funds available.

Members of the Texas Baptist Men’s Chainsaw Disaster Relief Team paid tribute to one of their own Dec. 8, spending the day clearing overgrown trees and branches from a food bank located in Terrell to honor James Larry Poston.

Poston had become a familiar face in Terrell and the surrounding area prior to his passing on Nov. 17, participating in numerous cleanup and community improvement efforts and mission trips over the years.

Born Aug. 20, 1946, to Bobbie and Virgil Poston, James graduated from South Oak

Cliff High School in 1964 and continued on to Navarro Junior College on a football scholarship.

He subsequently married his high school sweetheart Vicki in 1966 and received his degree at North Texas State University in Banking and Finance.

Poston managed a fertilizer plant in Terrell for Monsanto and El Dorado Chemical Company for 28 years before opening Poston Seed and Farm Supply in Poetry with longtime friend John Porter.

Poston stayed active into retirement by taking part in mission trips, hunting trips

Chitty to step down from ESD Board

After more than 16 years of service to Kaufman County as a representative of Emergency Services District #3, Harvey Chitty presided over his final meeting Dec. 14. To commemorate his dedication, members of the Ables Springs, College Mound, Elmo and Terrell Volunteer Fire Departments presented a special plaque to Chitty.

The members of Terrell Volunteer Fire Department extended their heartfelt thanks to Kaufman County Emergency Services District #3 Board President Harvey Chitty for his service and dedication to the local community at the board’s December meeting.

In a subsequent Facebook post TVFD officials stated, “Harvey Chitty will be retiring at the end of the month after more than 16 years of faithful service to the ESD. Many don’t know much about the ESD beyond it being one more charge on your annual property tax statement, but to the ESD #3 fire departments, the ESD represents the lion’s share of our annual funding and the reason why we have been able to consistently improve the service we provide our residents and visitors.

“The ESD commissioners volunteer their time to attend monthly meetings, review re-

and took approximately seven months to complete. The projects began in August 2020, and were completed in March 2021. The Colquitt Road section of the project involved a complete reconstruction of the 2.75-mile road and the replacement of a bridge and culverts. The 2.37-mile Samuels Road section of the project also included the complete reconstruction of the asphalt road and replacement of a decades old wooden bridge. The combined approximate cost of these two projects, which were funded through the 2019 bond funds, was just over \$2.058 million.

In the coming weeks, Precinct 3 will also celebrate the completion of three more bond projects which include FM 243, 322, and 346. Dates and locations are to be determined.

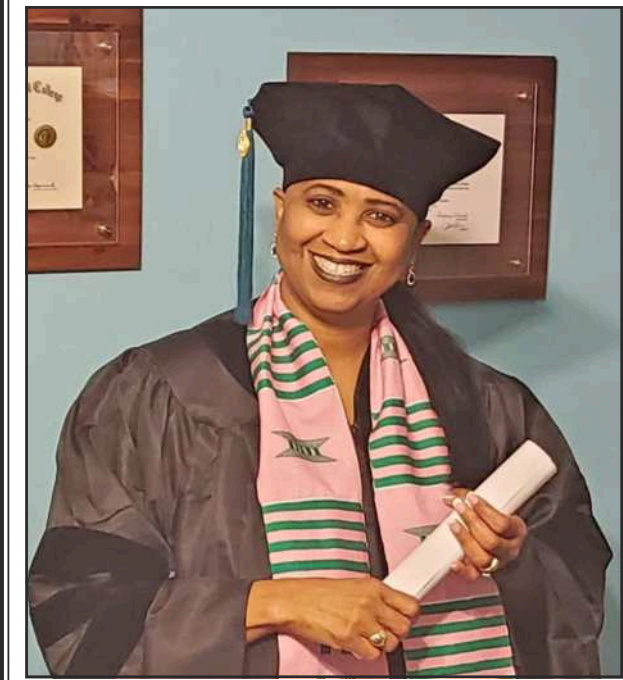

Kaufman County Expunction Expo underway

Kaufman County kicked off the Kaufman County Expunction Expo recently to help people who are eligible, by law, to have their criminal records erased.

Kaufman County District Attorney Erleigh Norville Wiley and District Clerk Rhonda Hughey teamed up to offer this service to those who might be held back from life advancement opportunities by an arrest for a minor charge that has not been addressed.

“Our goal is to make expunctions accessible to those who might not be able to afford an attorney or know how to navigate this legal system,” Judge Wiley said. “Sometimes it may be a case of being arrested years ago and there were never any charges filed,

but the arrest was still on the record, and this provides an opportunity to clear a case like that off your record.”

“An expunction of a past record will eliminate those things that could be holding you back in life,” said District Clerk Rhonda Hughey. “This gives you an opportunity to not only change the course for yourself, but also generationally.”

Hughey said she understands some may be skeptical about the Expunction Expo, but reassured people that if eligible – this is a total expunction.

The application process for the program is set to run through December 31, 2021, and volunteer attorneys from the Kaufman Bar Association

will help those who register to determine if they meet the requirements for expungement.

People Possibly Eligible

-Arrested but a charge was never filed with the DA’s office or was no billed by the grand jury.

-The criminal charge was dismissed without any type of community supervision or probation prior to dismissal, except for Class C offenses.

-Successfully completed Class C deferred adjudication.

-Acquitted or found “not guilty” on a charge by a judge, jury, or appellate court.

-Convicted of a crime but later pardoned by the Governor of Texas or the President of the United States.

People Possibly Not Eligible

-The case is still pending.

-Convicted, even if just a fine was paid.

-Placed on probation, community supervision or deferred adjudication for any felony or Class A or B misdemeanor, even if the case was later dismissed.

-Convicted or received any kind of probation on another felony offense arising from the same arrest.

Applicants will be notified in January if they are eligible to attend the pre-qualification clinic in March. There is no legal fee associated with the expo for participants and the county clerk filing fee is waived for participants with the program.

“Having something just hanging out there on your record can stop you from getting

jobs, it can stop you from getting a license, it can stop you from renting an apartment if you have a case on your record that you have not taken care of,” Judge Wiley said.

Hughey agreed, “I once heard an individual say they had been carrying around their arrest for 20-something years and it held them back, but by having this one opportunity to have it removed, they knew their life was going to change. We know this is very impactful, and we know this is the change people need in their lives.”



and attending his grandson’s activities.

In the early 1980s the Poston family joined First Baptist Church in Wills Point where James served as a deacon, a Sunday School teacher, a mis-

sion worker and a servant to anyone in need.

According to Poston’s obituary, “Some of his favorite mission trips were to Brazil, Mexico and Beaumont, Texas. In later years he joined the Texas Baptist Men Chainsaw Disaster Relief and served in Louisiana and in Texas. Recently he served with Meals on Wheels with Vicki and with the Food Pantry.”

Through a variety of efforts, including the Chainsaw Disaster Relief Team, the Texas Baptist Men have responded to every natural disaster in Texas

since 1967 and many beyond it, including the Southeast Asia tsunami, Hurricane Katrina and the Sept. 11 terrorist attacks.

In keeping with Poston’s desires to help the local food pantry in Terrell, members of the Texas Baptist Men’s Chainsaw Disaster Relief Team spent Dec. 8 cutting

down and trimming trees, and disposing of branches to help ease pickup and deliveries.

Organizers behind the effort last week were quick to credit Poston for his years of service to the community, adding that cutting down the trees was a way to honor his life and legacy.

Slow start sinks Lady Tigers in 74-55 loss

The Terrell Lady Tigers hit the most critical stretch of their season this week, tipping off District 13-4A play against the Sunnyvale Lady Raiders.

A slow start would prove to be too much to overcome in the contest as the Lady Tigers fell 74-55 to Sunnyvale.

The Lady Raiders looked to

be well on their way to a run-away win in the game's opening minutes, racing out to a 17-5 lead. The Lady Tigers would battle back before the close of the first quarter, outpacing Sunnyvale 9-2 to pull to within 19-14 after eight minutes of play.

Sunnyvale regained control of play before halftime, taking advantage of multiple missed opportunities by the Terrell of-

fense to build a 33-20 lead.

The Lady Raiders would add six more points to their advantage in the third quarter before Terrell and Sunnyvale battled to an 18-18 draw over the game's final eight minutes.

Darliscia Coleman finished with a game-high 26 points, followed by Hope Burks with 18 points, Te'niah Turner with six points and Charravia Smith with five points.

Brinley Andrews led Sunnyvale with 25 points, followed by Takoya Stallings with 23, Micah Russell with 11, Alli Mcada with nine, Nilaya Gordon with four and Kendra Meras with two.

Current District 13-4A standings show Farmersville, Caddo Mills and Sunnyvale tied for first at 1-0, followed by Ford at 0-0, and Terrell, Kaufman and Nevada Com-

munity at 0-1. The top four finishers in district play will advance to the bi-district round of the playoffs.

Terrell is scheduled to take on the Kaufman Lady Lions in Kaufman Dec. 21 before embarking on their Christmas break. Other upcoming dates for Terrell will include a home date against Nevada Community Jan. 4 and a trip to take on the Ford Lady Panthers Jan. 7.

Texas Lottery encourages gifting responsibly

As Texans enjoy many opportunities for gift giving, the Texas Lottery is urging consumers not to give lottery tickets to children. For the 13th year, the Texas Lottery is partnering with the National Council on Problem Gambling (NCPG) and the International Centre for Youth Gambling Problems and High-Risk Behaviors at McGill University to raise awareness of the risks of underage lottery play by reminding lottery consumers to “Gift Responsibly. Lottery Tickets Aren’t Child’s Play.”

In Texas, players must be at least 18 years of age to purchase lottery tickets and retailers are not authorized to redeem tickets for anyone under the age of 18. “Lottery products can be a great gift or stocking stuffer, but we want to remind shoppers that Texas Lottery games are not an appropriate gift for individuals

younger than 18 years old,” said Gary Grief, executive director of the Texas Lottery.

We are proud to support NCPG and McGill University’s 2021 Gift Responsibly campaign with organizations around the world, as we remain committed to our social responsibility of urging our players to play and gift responsibly not just during the holiday season, but throughout the year.”

According to research by NCPG and McGill University, early gambling experiences are a risk factor for later problem gambling. In addition, adult problem gamblers report an earlier onset of gambling, often beginning between ages 10-19.

Throughout December, the “Gift Responsibly. Lottery Tickets Aren’t Child’s Play.” message will be featured on the Texas Lottery’s social



media accounts, website, retailer newsletter and in-store electronic messaging. Educational messages regarding the risks of underage gambling will be sent to retailers and employees throughout the month. Certified for its Responsible Gambling program by NCPG and the World Lottery Association, the Texas Lottery emphasizes responsible gambling in its marketing efforts and promotional materials throughout the year, all of which encourage respon-

sible play and remind consumers that you must be 18 or older to purchase a lottery ticket.

More than 20,000 lottery retailers across the state also are trained and reminded that lottery tickets should not be sold to or prizes redeemed by anyone under the age of 18. Information on how to find help for problem gambling is available on Texas Lottery’s games, website, social media and advertising.

About the Texas Lottery

Beginning with the first ticket sold in 1992, the Texas Lottery has generated \$33.8 billion in revenue for the state and distributed \$72 billion in prizes to lottery players. Since 1997, the Texas Lottery has contributed \$27.9 billion to the Foundation School Fund, which supports public education in Texas.

As authorized by the Texas Legislature, certain Texas Lottery revenues benefit state programs including the Fund for Veterans’ Assistance. Since the first veterans’ themed scratch ticket game was launched in 2009, the Texas Lottery has contributed more than \$169 million for programs supporting Texas veterans.

The value of real Christmas trees in Texas

Christmas trees have been a tradition in the United States for over a century and today, when most families begin searching for the perfect Christmas tree, it comes down to one question – real or artificial? While there are many pros and cons to having a real or artificial tree during the holiday season, one thing is certain – real Christmas trees add great value to both the national and state economies.

“There’s just something special about having a real Christmas tree around during the holidays,” said Aaron Stottlemeyer, Texas A&M Forest Service Forest Resource Analyst. “Not only are they beloved for the authenticity they bring to celebrations, but they add so much value to our economy and benefit the environment.”

When it comes to Christmas tree farms, many might think of northern states, covered in white, glistening snow. Actually, Christmas trees are grown in all 50 states. According to the National Christmas Tree Association, almost 350 million Christmas trees are currently growing on 15,000 tree farms across the country, covering 350,000 acres.

For the Lone Star State, Dr. R. R. Childers was the first on re-



cord to plant Christmas trees in 1935 in Jasper, Texas. And since the 1970s, entities such as Texas A&M Forest Service, Texas A&M University and Stephen F. Austin University have been working on growing optimal species in the state to increase production and sales for Christmas tree growers. The most commonly grown trees in Texas are Virginia pine, Afghan pine, eastern redcedar, shortleaf pine, Arizona cypress and Leyland cypress.

These species thrive in Texas soils and tend to be hardy, fast-growing trees. They also contribute to the state’s economy, by providing jobs and income to Texans.

Artificial trees made of PVC

plastic became fashionable in the 1980s, but even as they have grown in popularity over the last 40 years, real Christmas tree sales remain higher across the nation. On average, Texas sells over four million real Christmas trees per year, about 12% of the U.S. total. And while you can purchase trees from large retail stores, many tree sales come from local growers.

“Texans can take pride when purchasing real Christmas trees,” said Stottlemeyer. “By purchasing real Christmas trees, they are supporting local growers and benefitting rural Texas economies.”

Texas A&M Forest Service recently conducted an economic study showing just how much

value the real Christmas tree industry adds to the state. Including total direct impacts and all other ancillary industry activities, in 2020 the Christmas tree industry generated over \$800 million and supported nearly 7,000 jobs with a payroll of \$260 million.

When contrasted with artificial Christmas trees, the nation and state do not see nearly the economic benefits as provided by real trees, as they are largely manufactured in foreign countries.

“Unlike artificial Christmas trees, the real Christmas tree industry has a continuous cycle of economic benefit for our state,” said Stottlemeyer. “There is a significant domestic economic impact from real Christmas trees considering that they are planted, managed, harvested, processed, transported and sold only to start the entire cycle again by planting new seedlings each year.”

How do these numbers rank compared to other states? In 2019, the U.S. Bureau of Labor Statistics estimated the Texas Christmas tree industry ranked second in the U.S. South for average annual employment and wages behind Florida, and fourth nationally after California, Florida and Oregon.

Not only do real Christmas

trees add value to our state economy, but they also benefit our environment. Much like forests, Christmas trees growing on tree farms reduce soil erosion, improve water quality and provide habitat for wildlife.

Like other trees, Christmas trees also add value to our lives by sequestering carbon, producing oxygen and cleaning the air we breathe. Similar to having plants or fresh cut flowers around, real trees also help boost energy and mood and decrease mental fatigue – which can be much needed during the rush of the holiday season.

“Purchasing real Christmas trees is purchasing a renewable resource,” said Stottlemeyer. “Real trees provide numerous environmental benefits and are a true green option to enjoying the holidays.”

Real Christmas trees are both renewable and recyclable. Many communities provide opportunities to recycle trees. Trees can easily be mulched to be used in yards, around the bases of trees or in gardens to help prevent soil erosion and compaction. Trees can also create habitat for wildlife or fish if placed outdoors or in ponds.

Real Christmas trees add real value to the Texas environment and economy, and to Texans’ health, jobs and local businesses.
