Rice Road 40B size issue comes to a head

Public hearing likely extended to June

MILLBURY — Members of the Millbury Board of Appeals challenged developer SJV Development on the height and size of the 17 Rice Road development, which comes in at 192 rental units in four story buildings more than 60 feet high on a slope that is higher than the surrounding neighborhood.

"It could be close to the highest building in town," noted ZBA member Harold Proodian. "We build schools in town that we don't go that high."

While SJV representative James

Venincasa asked what could be done differently to "blunt the height issue." he stood firm on the number of units and therefore the number of stories to the buildings.

"We are not willing to reduce down the unit count," Venincasa said, although he said they would consider other changes that the board might

"We feel as though everything that we've provided, does show you that we can make 192 units work..., I don't see the reason to reduce down

the unit count, if everything works," Venincasa said. "The state is pushing for affordable housing; density is how you accomplish that."

Venincasa lauded his company's contribution to the town and the quality of their other projects in town.

Venincasa asked for a straw poll of the board on the building height and size, and received scattered comments. He discussed whether moving the building closest to abutter Cody Mathieu would help, which several members had mentioned.

Members remained concerned, a concern that one board member said could impact the project.

"That's two votes very concerned about the height," board of appeals member Adam Kobel said. "One more person concerned about that height, and you don't get a waiver."

Abutter Cody Mathieu has asked the board members to visit his property to view the site and understand the impact of the development on his property. A balloon test, where ballons the height of the proposed building are floated to help viewers visualize the impact, has also been suggested by the board.

Attorney Harold Lane, who

Three races contested in **Millbury Town Election**

MILLBURY — This year's annual town election April 30 will include several contested races for the select board, planning board and school committee.

For the select board, five contestants are running for two seats. Incumbent Katherine McKenna will run again; Francis P. Desimone, Daniel R. Jakes, Nicholas J. Lazzaro and Amy M. Paquette-Riordan are all running as well. Each select board seat is for three years.

A hot race for two seats on the planning board pits former planning board member Terry Burke Doston (who lost to Tony Ngo in 2023) against incumbents Francis P. Desimone and Paul A Piktelis.

The school committee has two seats up for election; incumbents Christopher Wilbur and Kristen M, Birch are running again, and Sean Michael Cooper is challenging for a seat on the

Francis P. Desimone is allowed to run for seats on both the planning board and the select board, but, if elected, can only serve on one of the boards, according to Town Clerk Jayne Davolio.

No one returned nomination papers to run for a one-year seat open on the school committee or for the one-year moderator position. At the town election, voters can write-in candidates for the moderator seat.

For the moderator seat, more than five write-in votes are necessary to be nominated; the top vote getter with more than five votes will be offered the position. If they decline, the issue will come before town meeting

For other boards, incumbents are the only candidates on the ballots: Jonatham M. Cammuso, is running again for a threeyear stint on the board of assessors; John H, Dufresne, is running again for a three-year stint on the board of health; Carol F. Burke and Keith A. St. Denis are running for threeyear seats on the library board of trustees; Alecia Marie Cox Miller and Harold F. Proodian are running for two five-year seats on the re-development authority.

Voters can cast their ballots for the annual town election on Tuesday, April 30 from 7 a.m. to 8 p.m. at Millbury Memorial Junior/Senior High School. There are no mail-in ballots or early voting for this election, Voters may request an absentee

Candidates for contested seats are invited to share a 500-word candidate's statement to be printed in the Chronicle's April 25th issue. Statements are due April 19.

Sutton magician sentenced to more than six years in prison for child pornography offenses

Defendant regularly performed for young children across New England for over 20 years

BOSTON — A Sutton man who worked as a magician for over 20 years was sentenced March 28 in federal court in Boston for exploiting children in Cambodia.

Scott Jameson, 47, was sentenced

by U.S. District Court Judge foreign place and one count of trans-Richard G. Stearns to 78 months in prison to be followed by five years of supervised release. Jameson was also ordered to pay \$20,000 in special assessments. In November 2024, Jameson pleaded guilty to one count of illicit sexual conduct in a

portation of child pornography.

"Scott Jameson thought that by travelling overseas to Cambodia in order to sexually exploit children, he could get away with it. He was wrong," said Acting United States Attorney Joshua S. Levy. "Sexual

exploitation of children is unconscionable, regardless of where the victims live. Our office works with international authorities regularly to make sure that individuals like Mr. Jameson are held accountable

LETTER FROM THE EDITOR

Your home, your town, your government

When I bought my first home, I was so wet behind the ears that it pains me now to look back on it: I had to be told that not every town provided public water and sewer; I didn't know until the inspector told us that there was the possibility of lead paint in my suburban Cape; and I didn't know anything about the town where I was buying a home that I might live in for the rest of my life. I had heard that the town's schools generally had a good reputation, but that's as far as it went.

Learning about the town one buys property in now seems to me one of the most important things one can whether your property ends up next

do. Perhaps because, since buying my own home, I've spent countless hours in select board, school committee and planning and zoning meetings in the Wachusett Region and now, in Millbury and Sutton, and I've learned a thing or two.

Probably most important has been that what these volunteer folks do in their meetings can have a far more profound effect on daily life in your town than most things that happen at a national level.

Financially, they decide, not only how high your taxes will go, but how much you'll pay for water and sewer and trash removal or disposal.

Planning and zoning will decide

to a full-scale development or a warehouse. Conservation, just as the word sounds, makes sure the natural resources around you are respected and protected, by builders and everyone

Recreation may decide how you spend your weekends and how your children spend their summer days, or how interested they become in sports.

For some of us, the decisions the library trustees make will make or break our experience there, for both leisure time and education.

And on the school committee level, if you have children, they'll decide everything about your child's experience in school, especially things that will make them love or hate school;

things that will encourage or discourage them from pursuing the future they want; things that will help them build a foundation for everything from loving books to building a skyscraper; things that will affect their mental health.

Almost everything you need to know about your town government, and how it can profoundly affect your everyday life, is found at these meetings. Watch a meeting sometime (they're recorded and easy to find). And with the town election coming, think carefully about who serves on these committees and how they run your town.

And if you ever decide to move, watch their meetings before you sign





for their criminal conduct. We will not cease in our efforts to bring individuals who harm children to justice."

"This predator with a passport traveled halfway around the world and engaged in illicit sexual conduct with a child and then brought back home evidence of that sexual abuse so he could relive it for his own sick gratification," said Jodi Cohen, Special Agent in Charge of the Federal Bureau of Investigation, Boston Division. "Child sexual exploitation is abhorrent anywhere it occurs, and the FBI will continue to go after Americans who travel abroad for that purpose. We're determined to bring them to justice for the damage they've done and prevent them from victimizing anyone else's child."

In early 2022, Action Pour Les Enfants (APLE), a Cambodian Non-Governmental Organization founded to prevent child sexual abuse and exploitation, contacted federal authorities in the United States to report that Jameson engaged in inappropriate behavior with minors

in Cambodia. An investigation revealed that, while in Cambodia, Jameson would provide gifts and money to children and their families. Children reported that he would visit the pagoda where they lived and sleep in a room with the children.

In September 2022, authorities in the United States were notified that Jameson, a dual citizen of the United States and Ireland, had again traveled from Boston to Cambodia in August 2022. Upon his return to the United States on Oct. 19, 2022, Jameson was stopped at Logan Airport. During a search of his belongings, a video was discovered which he produced during his most recent trip to Cambodia, depicting the genitals of a young boy who was approximately seven years old. Jameson admitted to creating the video and transferring it from his camera to a hard drive that he possessed when he was stopped at Logan Airport. Additionally, Jameson's laptop revealed that it had been used to view images of child sexual exploitation material.

During a subsequent interview with law enforcement, Jameson stated that he worked as a magician for over 20 years, regularly per- M. Noto of the Worcester Branch forming at libraries and private and family events across New England, usually for children as young as kindergarten age and up to the eighth grade.

FBI SAC Cohen made the announcement today. Valuable assistance in the investigation was provided by United States Customs and Border Protection, Homeland Security Investigations and the Sutton and Littleton Police Departments. Assistant U.S. Attorney Kristen Office prosecuted the case.

This case was brought as part of Project Safe Childhood, a nationwide initiative to combat the growing epidemic of child sexual exploitation and abuse, launched in May 2006 by the Department of Justice. Led by the U.S. Attorneys' Offices and the DOJ's Child Acting U.S. Attorney Levy and Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to locate, apprehend, and prosecute individuals who exploit children, as well as identify and rescue victims. 

Baseball and poetry change the life of Sutton writer

SUTTON — Cheryl Bonin was a social worker for 30 years and now looks back on her career through the lens of a writer: "The kind of writing I did, you couldn't be creative," she says. "It was, 'Just the facts, ma'am."

Bonin might not have known the writer inside her but for a life-changing event: a few years ago, she was diagnosed with stage 4 metastatic breast cancer.

As part of her treatment, those who were overseeing her care suggested she find an outlet for her feelings.

"I decided to start writing, because it was cheaper than therapy," she says.

The writing took the form of poetry and essays.

While Bonin had written in high school (the sort of teenage angst that many teens write), it had been a long time. But it was the beginning of Bonin finding, not just an outlet for a lot of feelings, but an important path. She found a poetry group at Booklover's Gourmet in Webster and went to her first meeting with one poem. She found the folks there so welcoming and encouraging that she took their advice: "Write more!"

Bonin became involved with poetry events in the Worcester area, and finally submitted a

poem to the Worcester County Poetry Association contest, the Frank O'Hara contest.

The results were staggering to her: "I won first place!" First prize was a \$25 check. She never cashed it. Now she looks at it as incentive.

That's the point where two branches of Bonin's life intersect.

She recalls growing up as the boy her father never had, and for that reason ending up being the one he shared his love of baseball with. She played baseball all the way through school and coached her daughter's team, shared her love of baseball with her daughter, and experienced as much baseball fun as she could. She visited Cooperstown and met Jerry Remy, and through an event thrown by her husband's employer, Coca Cola, got to play a little baseball at Fenway and touch the Green Wall.

And naturally, she was thrilled when Polar Park opened

It was only a matter of time, of course, before Bonin's love of poetry and her love of baseball intersected.

Last year she heard about the National Baseball Poetry contest taking place, and choosing Polar Park for its venue, no doubt because of the baseball poem of all time written here by Ernest Lawrence Thayer: Casey at the Bat. Bonin knew she had to enter. She was one of 20 chosen to receive recognition from the contest. Her poem was published on BaseballBard. com, and she received a certificate.

She's now a member of the organizing committee for the fledgling organization, which is entering its second year.

She encourages all who love baseball and poetry to enter (see sidebar).

But she also encourages teens who may have felt as she did, that they can't write the kind of rhyming poetry they learn in school: it doesn't have to be that way, there are no rules.

"Poetry is way more than just Shakespeare or what you learned in high school," she says.

represents several abutters to the project presented a PowerPoint citing many of the issues regularly raised about the project, including its scale in the neighborhood of single-family homes and the nearby railroad crossing which Lane called "unprotected." Lane also highlighted the distance from the nearest abutter, the property belonging to Cody Mathieu. One part of the development is only 34 feet from the Mathieu home. The nearest building of the development is up a slope and more than 60 feet high, looming over the Mathieus' back yard.

Lane encouraged the board to "do the right thing," and reject the project, likely sending it to the state's Housing Appeals Committee if SJV appeals the rejection.

Providence and Worcester Railroad representative Robert Garland also spoke at the meeting, saying the company was "strongly opposed to expanded use of the Rice Road railroad crossing."

Garland said the increased traffic also increases the possibility

of accidents such as trains vs. cars and trains versus pedestrians. Garland said the company's stance was that even one more car across the crossing was unacceptable.

Garland said the crossing is safe currently and maintained according to Federal Railroad Association standards.

In public commentary, Steve Stearns said he recalls gates that were formerly at the crossing, which he said is only 19 feet wide. Stearns said the gates were removed in 1979.
